## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On December 20, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your children were eligible for Child Health Plus, effective February 1, 2017. Also on December 20, 2016, NYSOH issued a notice of enrollment confirmation stating that your children were reenrolled in their Child Health Plus plan as of February 1, 2017. You appealed that determination.

On August 11, 2017, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date.

On August 25, 2017, a Hearing Officer from the Appeals Unit of NYSOH called you and placed you under oath.

While under oath, you identified yourself, waived your right to formal notice of the proceeding, and stated that you were no longer interested in pursuing your appeal because your children's Child Health Plus plan had reenrolled your children in their Child Health Plus plan effective December 1, 2016, consistent with the May 27, 2017 enrollment notice issued by NYSOH.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
