NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On March 11, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you did not qualify to select a health plan outside of the open enrollment period for 2017, effective April 1, 2017. You appealed that determination.

On June 23, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath. At that time, you requested an adjournment and the Hearing Officer agreed to reschedule your hearing to June 29, 2017 at 10:00 a.m. On June 29, 2017, the Hearing Officer called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because on June 20, 2017, NYSOH issued a redetermination notice stating that you were newly eligible to purchase a qualified health plan at full cost through NYSOH, effective August 1, 2017. The notice stated that you had until August 18, 2017 to confirm your health plan selection. While you had not yet made your health plan selection you were aware of your eligibility to do so.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
