NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On March 2, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your [REDACTED] was not eligible for Medicaid for December 1, 2016 through December 31, 2016. On March 8, 2017, NYSOH issued a notice of eligibility determination stating that your [REDACTED] was not eligible for Medicaid for January 1, 2017 through February 28, 2017. You appealed these determinations.

On June 2, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 13, 2017, at 1:00 pm.

On July 13, 2017, you spoke with a Hearing Officer and requested that your hearing be adjourned to July 18, 2017 at 1:00 pm. The Hearing Officer granted your request.

On July 18, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 1:00 pm, 1:15 pm, and 1:30 pm, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled and show good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
