## NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On March 21, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating you were eligible to receive up to \$56.00 in advance payment of the premium tax credit monthly, effective May 1, 2017. You appealed this determination.

On June 7, 2017, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for July 13, 2017, at 2:00 p.m.

On July 13, 2017, a Hearing Officer called the telephone number you provided to NYSOH, [REDACTED], at 2:02 p.m. An individual who identified themselves as your mother answered and indicated you were not available, because you were at work, and the telephone number was her home telephone number. The individual provided an alternate telephone number to contact you, [REDACTED] and indicated it was the number to your cell phone. The Hearing Officer placed two calls to that alternate telephone number at 2:10 p.m. and at 2:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
