Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were eligible to enroll in the Essential Plan, effective March 1, 2017, and not eligible for Medicaid?

Procedural History

On February 22, 2017, NYSOH received your update application for health insurance.

On February 23, 2017, NYSOH issued an eligibility determination notice stating in relevant part that you were eligible to enroll in the Essential Plan with no monthly premium, effective March 1, 2017. The notice further stated that you qualified for the Essential Plan because your income was less than the allowable income limit and you were in the first five years of your qualified immigration status or you are living in the United States under the color of law.

Also on February 23, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in the Essential Plan 4 with no monthly premium, starting March 1, 2017.

On March 22, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of the February 23, 2017 eligibility determination notice insofar as you were not eligible for Medicaid.

On June 27, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to July 11, 2017, to allow you to submit supporting documents.

On July 10, 2017, you contacted NYSOH and requested additional time in which to submit documents.

On July 17, 2017, NYSOH Appeals Unit received your nineteen-page submission via facsimile. This documentation consisted of a memorandum from you stating you have misplaced your work authorization cards and your green card and were in the process of requesting duplicates. You also submitted a form I-797, Notice of Action, dated December 29, 2015, stating your request for permanent resident status had been granted with an admission date of June 27, 2013. The facsimile submission also included receipts for various documents included your Employment Authorization Card [REDACTED]. These documents have been collectively made part of the record as "Appellant's [REDACTED]."

The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and your testimony, you will be filing taxes with a filing status of head of household (with qualifying individual) and claiming one dependent on your tax return.
- 2) Your application states that states you are an immigrant non-citizen.
- 3) You testified that you first came to the United States more than 20 years ago, and have resided in the United States since then.
- 4) You are seeking to be found eligible for Medicaid.
- 5) You were previously enrolled in a Medicaid Managed Care plan through NYSOH until February 28, 2017.
- 6) You testified that you have a permanent resident card but that the card has been misplaced and you have submitted a request for a new card.
- 7) According to the documentation submitted with Appellant's [REDACTED], you were granted permanent resident status as of your admission date of June 27, 2013.

- 8) The application that was submitted on February 22, 2017, in which you requested financial assistance, listed annual household income of \$0.00.
- 9) Your application states that you live in [REDACTED], New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Federal Register 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

Medicaid

A person who meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard is eligible for Medicaid benefits (45 CFR § 155.305(c)). One of the non-financial criteria for Medicaid eligibility is the immigration status of the person applying for health insurance. A person is eligible for Medicaid when his or her immigration status is satisfactory and he or she meets all other requirements for Medicaid (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your applications, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Qualified Immigrants

In NY State, qualified immigrants who were formerly eligible for Medicaid through the state, but not eligible for Medicaid under federal law, were transitioned to the Essential Plan as of January 1, 2016 (New York’s Basic Health Plan Blueprint, p. 19, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>). This category of qualified immigrants includes individuals lawfully admitted for permanent residence in the United States who are still in their first five years of permanent residency. (18 NYCRR § 349.3, 8 USC § 1613).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were eligible to enroll in the Essential Plan, effective March 1, 2017, and not eligible for Medicaid.

The application that was submitted on February 22, 2017, listed an annual household income of \$0.00 and the eligibility determination relied upon that information.

According to your application, you are in a two-person household. This is because you expect to file your 2017 income taxes as head of household (with qualifying individual) and will claim one dependent on that tax return.

The Essential Plan is provided through NYSOH to individuals who are lawfully present non-citizens, who are ineligible for Medicaid or Child Health Plus as a result of their immigration status, and have a household income that is between 0% and 200% of the FPL. Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size.

On the date of your application, the relevant FPL for 2016 was \$16,020.00 and the relevant FPL for 2017 was \$16,240.00 for a two-person household. Since an annual income of \$0.00 is 0.00% of the 2016 FPL and 0.00% of the 2017 FPL, you meet the financial eligibility criteria for both the Essential Plan and Medicaid.

However, you provided a copy of the I-797, Notice of Action, dated December 29, 2015 that stated you were approved for permanent resident status effective June

27, 2013. You also testified that you are a permanent resident, and have had permanent resident status since June 27, 2013. Therefore, as of your February 22, 2017 application, you have been a permanent resident for approximately three years and seven months. As of January 1, 2016, legal permanent residents who were receiving Medicaid through NY State, but were not eligible for Medicaid under federal law due to being in the first five years of their permanent residency, must now receive coverage through the Essential Plan. Therefore, because you are in your first five years of permanent residency, NYSOH properly determined that you do not meet the non-financial requirements for Medicaid.

Since you meet the non-financial and financial requirements for the Essential Plan, NYSOH properly determined you to be eligible for Essential Plan coverage.

Therefore, since the February 23, 2017, eligibility determination notice properly stated that, based on the information you provided, you were eligible for the Essential Plan effective March 1, 2017, it was correct and is AFFIRMED.

Decision

The February 23, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for the Essential Plan.

You are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
