## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's enrollment in his Medicaid Managed Care plan was effective May 1, 2017?

## Procedural History

On January 31, 2017, you updated your application for financial assistance.

On February 1, 2017, NYSOH issued a notice of eligibility determination stating that you were conditionally eligible for Medicaid, effective February 1, 2017. This notice directed you to provide proof of benefit information for third party health insurance by February 15, 2017.

On March 20, 2017, you updated your application for financial assistance to include your newborn child.

On March 21, 2017, NYSOH issued a notice of eligibility determination, based on your March 20, 2017 application, stating that your child was eligible for Medicaid, effective March 1, 2017.

Also on March 21, 2017, NYSOH issued a notice of enrollment in the plan you selected on March 20, 2017, stating that your child was enrolled in a Medicaid Managed Care plan, and that his coverage would start on May 1, 2017.

On March 24, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's enrollment in ■■■ Medicaid Managed Care plan, insofar as it did not begin March 1, 2017.

On June 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that your child was born on ■■■■■■■■■■
- 2) You testified, and your NYSOH account confirms, that you updated your NYSOH account to include your child on March 20, 2017.
- 3) You testified, and the record reflects, that you selected your child's Medicaid Managed Care Plan on March 20, 2017, and that ■■■ enrollment was effective on May 1, 2017.
- 4) You testified that at the time of your child's birth, you were covered by third party health insurance through your father's employer. You testified that you knew that you had been found eligible for Medicaid through NYSOH, but you did not enroll in a Medicaid Managed Care plan through NYSOH as you did not want to lose your third party health insurance through your father's employer.
- 5) You testified that you want your child's Medicaid Managed Care plan to begin on March 1, 2017 as you want your child to be covered under ■■■ Medicaid Managed Care plan as of the date of ■■■ birth, because you have medical bills that were not covered by Fee-For Service Medicaid for the months of March 2017 and April 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR §

435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

### Medicaid for Newborns

Medicaid coverage must be provided to a child born to a woman who has been determined eligible and is receiving Medicaid on the date of the child's birth (42 CFR § 435.117(a), N.Y. Soc. Serv. Law § 366-g(3)). Additionally, Medicaid Managed Care plans are contractually obligated to provide coverage to eligible newborns based on the transaction date of the enrollment of the newborn (Medicaid Managed Care Model Contract (Appendix H-6 effective 3/1/2014 – 2/28/2019)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your child's enrollment in ■ Medicaid Managed Care plan was effective May 1, 2017.

You testified, and the record reflects, that you updated your application to include your child on March 20, 2017 and enrolled your child into a Medicaid Managed Care plan that day.

In New York State Medicaid coverage must be provided to a child born to a woman who has been determined eligible and is receiving Medicaid on the date of the child's birth. The record reflects that on the date of your child's birth, you were eligible for Medicaid, but not enrolled into a Medicaid Managed Care plan. Therefore, your child was not mandated to receive coverage through a Medicaid Managed Care plan as of ■ date of birth.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On March 20, 2017, you selected a Medicaid Managed Care plan for your child, so it properly took effect on the first day of the second month following after March 2017; that is, on May 1, 2017.

Therefore, the March 21, 2017 enrollment confirmation notice stating that your child's enrollment in ■■■ Medicaid Managed Care plan was effective May 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The March 21, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your child's eligibility.

The effective date of your child's Medicaid Managed Care plan is May 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
