## NOTICE OF DISMISSAL - FAILURE TO APPEAR

Dear ,

On March 8, 2017, NY State of Health (NYSOH) issued a plan enrollment notice, stating that you were enrolled in the Essential Plan, effective March 1, 2017. You appealed this determination.

On May 25, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for June 28, 2017, at 3:00 p.m.

A Hearing Officer called you at 3:00 p.m. on June 28, 2017. You answered and stated that you were at work and requested that the hearing be adjourned to Friday, July 7, 2017 at 3:00 p.m. The Hearing Officer agreed to adjourn the hearing to Friday, July 7, 2017 at 3:00 p.m. The Hearing Officer also explained that at the time of the adjourned hearing, you would have to waive your right to formal notice of the hearing. You stated that you understood.

On July 7, 2017, a Hearing Officer called to the telephone number that you provided to NYSOH, at 3:00 p.m. You answered, but stated that you were in a bad service area and you could not talk. The Hearing Officer stated that she could adjourned the hearing one more time. You asked if the Hearing Officer could call you back in an hour. The Hearing Officer informed you that the latest she could call was at 3:30 p.m. The call was then disconnected.

The Hearing Officer placed two more calls to the phone number you provided to NYSOH, at 3:17 p.m., and 3:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

## If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
