NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On March 25, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your children were eligible for Child Health Plus for a cost of \$9.00 per month each, effective May 1, 2017. You appealed this determination.

On May 25, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for June 29, 2017, at 10:00 a.m.

A Hearing Officer called you on June 29, 2017. Although you answered the call you explained you could not speak at the time as you were in [REDACTED] due to a [REDACTED] emergency. You explained the emergency had prevented you from contacting NYSOH earlier about your availability. An adjournment was granted to a new date and time of July 19, 2017 at 9:00 a.m. You agreed you would waive formal notice to a Notice of Hearing.

On July 19, 2017, a Hearing Officer placed three calls to the telephone numbers that you provided to NYSOH, at 9:00 a.m., 9:15 a.m., and 9:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
