Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your children's enrollment in their Child Health Plus plan was effective April 1, 2017?

Procedural History

On March 1, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your February 28, 2017 application, stating that your children were eligible to enroll in Child Health Plus (CHP) with a \$30.00 monthly premium each, effective April 1, 2017.

Also on March 1, 2017, NYSOH issued a plan enrollment notice, based on your plan selection on February 28, 2017, confirming your children were enrolled in a CHP plan, with a plan enrollment start date of April 1, 2017.

On March 27, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's CHP plan insofar as it did not begin March 1, 2017.

On July 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your children's eligibility.
- 2) According to your NYSOH account and your testimony, you submitted an updated application to NYSOH for financial assistance on February 28, 2017, and enrolled your children in a CHP plan that same day.
- 3) You testified that you need your children's CHP plan to begin on March 1, 2017, because you have uncovered medical bills for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for CHP is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for CHP begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children's enrollment in their CHP plan was effective April 1, 2017.

You testified that you contacted NYSOH on February 28, 2017 and enrolled your children into a CHP plan.

The date on which a CHP plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Therefore, the March 1, 2017 eligibility determination and plan enrollment notices stating that your children's eligibility for CHP and enrollment in their CHP plan was effective April 1, 2017, are correct and must be AFFIRMED.

Decision

The March 1, 2017 eligibility determination and plan enrollment notices are AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's CHP plan is April 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
