#### Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$253.00 per month in advance payments of the premium tax credit, effective May 1, 2017?

Did NY State of Health properly determine that you were eligible for costsharing reductions?

Did NY State of Health properly determine that you were ineligible for the Essential Plan?

Did NY State of Health properly determine that you were ineligible for Medicaid?

# **Procedural History**

On February 10, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, effective March 1, 2016.

Also on February 10, 2016, NYSOH issued a notice of enrollment confirming your enrollment in an Essential Plan with a plan enrollment start date of March 1, 2016.

On January 5, 2017, NYSOH issued a notice that it was time to renew your health insurance for the upcoming coverage year. That notice stated that based on information from federal and state sources, NYSOH could not make a decision about whether you would qualify for financial help paying for your health coverage, and that you needed to update your account by February 15, 2017 or you might lose the financial assistance you were currently receiving.

On January 30, 2017, you updated your application for financial assistance.

On January 31, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective March 1, 2017. This notice directed you to submit proof of your income by April 30, 2017 in order to confirm your eligibility.

Also on January 31, 2017, NYSOH issued a notice of enrollment confirming your enrollment in an Essential Plan with a plan enrollment start date of March 1, 2017.

On March 10, 2017, income documentation was uploaded to your NYSOH account.

On March 20, 2017, NYSOH reviewed the income documentation you submitted and recalculated your annual income based on this documentation. That day, NYSOH updated the income in your application based on this recalculation and submitted an application on your behalf.

On March 21, 2017, NYSOH issued a notice of eligibility determination stating that you were newly eligible to purchase a qualified health plan at full cost through NYSOH, effective May 1, 2017.

Also on March 21, 2017, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end effective April 30, 2017. This was because you were no longer eligible to enroll in the Essential Plan.

On March 27, 2017, you updated your application for financial assistance. Specifically, you updated your tax filing status. That day, a preliminary eligibility determination was prepared stating that you were eligible to receive up to \$253.00 per month in advance payments of the premium tax credit (APTC) and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective May 1, 2017.

Also on March 27, 2017, you spoke to NYSOH's Account Review Unit and appealed the determination, insofar as you are seeking additional financial assistance.

On March 28, 2017, NYSOH issued a notice of eligibility determination, based on the March 27, 2017 application, stating that you were eligible to receive up to \$253.00 in APTC and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective May 1, 2017. That notice also stated that you were not eligible for the Essential Plan or Medicaid because your income was over the allowable income limits for those programs.

On July 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) The application that was submitted on January 30, 2017 listed annual household income of \$23,400.00, tax filing status of married filing single, and listed no dependents.
- 2) On February 15, 2017, you faxed income documentation to NYSOH. This submission consisted of four paystubs. The first is for pay date January 20, 2017 for a gross pay amount of \$475.00; the second is for pay date January 27, 2017 for a gross pay amount of \$475.00; the third is for pay date February 3, 2017 for a gross pay amount of \$475.00; the fourth is for pay date February 10, 2017 for a gross pay amount of \$475.00.
- On March 20, 2017, NYSOH recalculated your annual expected income to be \$24,700.00 based on the income documentation you submitted (\$475.00 multiplied by 52 weeks).
- 4) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 5) You are seeking insurance for yourself.
- 6) The application that was submitted on March 27, 2017 listed annual household income of \$24,700.00, consisting of wages you earn from your employment. You testified that this amount was correct.
- 7) You testified that you have one employer and that you are paid \$475.00 each Friday.
- 8) Your application states, and you confirmed, that you will not be taking any deductions on your 2017 tax return other than the standard deduction.

9) Your application states, and you testified, that you live in

in .

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

#### **Cost-Sharing Reductions**

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

#### **Essential Plan**

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

#### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

# **Legal Analysis**

The first issue is whether NYSOH properly determined that you were eligible for APTC of up to \$253.00 per month.

The application that was submitted on March 27, 2017 listed an annual household income of \$24,700.00 and the eligibility determination relied upon that information.

You expect to file your 2017 tax return as single and will claim no dependents on that tax return, therefore, you are in a one-person household.

You reside in where the second lowest cost silver plan available for an individual through NYSOH costs \$390.79 per month.

An annual income of \$24,700.00 is 207.91% of the 2016 FPL for a one-person household. At 207.91% of the FPL, the expected contribution to the cost of the health insurance premium is 6.71% of income, or \$138.15 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$390.79 per month) minus your expected contribution (\$138.15 per month), which equals \$252.64 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$253.00 per month in APTC.

The second issue is whether you were properly found eligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$24,700.00 is 207.91% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$24,700.00 is 207.91% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

The fourth issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$24,700.00 is 204.81% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that you are paid \$475.00 each Friday. As there were five Fridays in the month of March 2017, you monthly income for March 2017 was \$2,375.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since the testimony you provided indicates that you earned \$2,375.00 in March 2017 you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the March 28, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$253.00 per month in APTC, eligible for cost-sharing reductions, ineligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

#### Decision

The March 28, 2017 eligibility determination notice is AFFIRMED.

## How this Decision Affects Your Eligibility

You remain eligible for up to \$253.00 in APTC.

You are eligible for cost-sharing reductions.

You are ineligible for the Essential Plan.

You are ineligible for Medicaid.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
