NOTICE OF DISMISSAL – FAILURE TO APPEAR

On March 28, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you do not qualify to select a health plan outside of the open enrollment period for 2017, effective May 1, 2017. You appealed this determination.

On June 6, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 17, 2017, at 1:00 pm.

On July 17, 2017, a Hearing Officer placed a phone call to you at 1:00 pm at the telephone number that you provided to NYSOH. You answered and placed the Hearing Officer on hold, at which time, the call was dropped. The Hearing Officer placed three additional calls to the telephone number that you provided to NYSOH, at 1:05 pm, 1:15 pm, and 1:30 pm, but was unable to reach you. The Hearing Officer also placed three calls to the alternate telephone number that you provided to NYSOH, at 1:06 pm, 1:16 pm, and 1:32 pm. An individual who identified themselves as your son answered the third phone call and advised that you were not available.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled and show good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
