Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you do not qualify to change qualified health plans outside of the open enrollment period, effective April 1, 2017?

Procedural History

On December 14, 2016, NYSOH issued a plan enrollment notice confirming your enrollment in a full cost platinum-level qualified health plan (QHP), with a monthly premium of \$618.79, effective January 1, 2017.

On March 8, 2017, NYSOH issued an eligibility determination notice, based on your March 7, 2017 updated application, stating that you were eligible to enroll in a QHP at full cost, effective April 1, 2017. That notice further stated that you do not qualify to select a health plan outside of the open enrollment period for 2017.

Also on March 8, 2017, NYSOH issued a change in mailing address notice stating that you changed your address to the address noted above within [REDACTED], NY but with a different zip code.

On March 27, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination notice insofar as you were not eligible to change health plans outside of the open enrollment period.

On June 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and your testimony, on February 28, 2017, you moved to a different zip code within the same city.
- 2) On March 7, 2017, you updated your application for health insurance and requested to change your health plan. You want to change metal levels and get a less expensive health plan.
- 3) You testified that the Healthcare.gov website states that you are eligible for a special enrollment period if you have a permanent move with a change in zip code. You further stated that when you attempted to change health plans, you were advised by a NYSOH representative that this is only the case if your current coverage is unavailable to you in your new zip code.
- 4) You testified that you selected a very expensive platinum-level QHP believing that you would be able to switch health plans when you moved.
- 5) You testified that, since filing your application on December 14, 2016, there have been no other major changes to your household.
- 6) You testified that you did not rely on any statements made by NYSOH that prevented you in enrolling in a different qualified health plan sooner.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective April 1, 2017.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On March 7, 2017, you submitted an application for health insurance and requested to change qualified health plans. On March 8, 2017,

NYSOH issued a notice stating that you do not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period to enroll in, or change to another health plan offered in NYSOH. To qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified that the Healthcare.gov website states that you are eligible for a special enrollment period if you have a permanent move with a change in zip code and you relied upon that information. However, the Healthcare.gov website is not an instrumentality or agent of NYSOH. Since the record does not indicate that NYSOH, by action or inaction, made an error or misrepresented information, a special enrollment period cannot be granted on this basis.

Moreover, a special enrollment period, based on change in zip code, can only be granted if the qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan because of that permanent move. Since your move did not result in access to a new qualified health plans, a special enrollment period cannot be granted on this basis.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's March 8, 2017 eligibility determination notice stating that you do not qualify to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

The March 8, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You do not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
