Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan was effective January 1, 2017?

Procedural History

On February 1, 2017, NYSOH issued an eligibility determination notice, based on your January 31, 2017 initial application, stating that you were eligible to receive up to \$197.00 per month in advance payments of the premium tax credits, effective March 1, 2017.

On February 28, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$380.60, after your advance payments of the premium tax credits of \$197.00 was applied, effective January 1, 2017.

On March 28, 2017, you spoke to NYSOH's Account Review Unit and appealed the plan enrollment notice insofar as it began your enrollment in a qualified health plan on January 1, 2017, and not March 1, 2017.

On July 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an initial application to NYSOH for financial assistance on January 31, 2017.
- 2) According to your NYSOH account, and your testimony, you selected a qualified health plan on February 27, 2017. Your enrollment in the plan became effective January 1, 2017.
- 3) You testified that you want your qualified health plan to begin on March 1, 2017 because you don't want to pay for two months of health coverage that you did not have access to and did not use health insurance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determine that your enrollment in a qualified health plan, was effective January 1, 2017.

The record shows that on January 31, 2017 you initially applied for health insurance through NYSOH. According to your NYSOH account, and your testimony, you submitted a request to enroll in a qualified health plan on February 27, 2017. On February 28, 2017, NYSOH issued plan enrollment notice stating that your enrollment in your qualified health plan was effective January 1, 2017.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected after the fifteenth day of a month goes into effect on the first day of the second following month.

You selected and enrolled in a plan on February, 27, 2017; therefore, your plan should have begun on the first day of the second month following February, that is on April 1, 2017.

Since NYSOH's February 28, 2017 plan enrollment notice improperly began your enrollment in your qualified health plan on January 1, 2017 it is MODIFIED to state that you are enrolled in your qualified health plan, effective April 1, 2017.

Decision

The February 28, 2017 plan enrollment notice is MODIFIED to state that your enrollment in your qualified health plan is effective April 1, 2017.

Your case is RETURNED to NYSOH to effectuate the change listed above, and to notify you accordingly.

This Decision has no effect on any subsequent notices issued by NYSOH.

How this Decision Affects Your Eligibility

Your enrollment in your qualified health plan should have begun as of April 1, 2017.

Your case is being sent back to NYSOH to effectuate this change. NYSOH will notify you once this change has been made.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
