Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for November 1, 2016 through November 30, 2016?

Procedural History

On March 10, 2017, NYSOH received an application for financial assistance with health insurance.

Also on March 10, 2017, NYSOH received a copy of your U.S. Passport.

On March 11, 2017, NYSOH issued a notice of eligibility determination stating that you were conditionally eligible for Medicaid. This eligibility was effective as of March 1, 2017. You were requested to provide proof of your U.S. citizenship by June 8, 2017 in order to finalize your eligibility.

On March 21, 2017, NYSOH redetermined your eligibility for financial assistance with health insurance.

On March 22, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid, without condition, effective March 1, 2017.

On March 28, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not found eligible for retroactive Medicaid during the month of November 2016.

On July 6, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking retroactive Medicaid coverage from November 1, 2016 to November 30, 2016.
- 2) You testified that you originally had Medicaid coverage through your Human Resources Administration/Department of Social Services (HRA/DSS), but that coverage had been terminated effective August 31, 2016. You further testified that you did not learn of this termination until you had incurred medical expenses during the month of November 2016.
- 3) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 4) You submitted your initial application for financial assistance on March 10, 2017. You testified that you did not indicate in your application that you were seeking help for paying for past medical expenses incurred within the prior three months, because you were seeking assistance with paying for medical bills incurred during the fourth prior month, which was November 2016.
- 5) Your application submitted on March 10, 2017 states that you had not received any income. You testified that you did not receive any income during the month of November 2016.
- 6) You testified that you incurred medical expenses during the month of November 2016, and were seeking for those medical expenses to be covered by Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

De Novo Review

NYSOH Appeals Unit must review each appeal de novo and “consider all relevant facts and evidence adduced during the appeals process” (45 CFR § 155.535(f)). “De novo review means a review of an appeal without deference to prior decisions in the case” (45 CFR § 155.500).

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for November 1, 2016 through November 30, 2016.

You testified that you are appealing the denial of retroactive Medicaid coverage for the month of November 2016. However, the record does not contain an eligibility determination notice explicitly stating that you were not eligible for Medicaid coverage during the month of November 2016.

Here, the lack of a notice of eligibility determination on the issue of retroactive Medicaid coverage does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination as you are to appeal an adverse notice of eligibility determination.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

You submitted your initial application for financial assistance on March 10, 2017. You testified that you did not request help for paying for medical bills incurred during the three prior months in your application, because you were seeking assistance with paying for medical bills incurred during the fourth prior month, which was November 2016.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid from November 1, 2016 to November 30, 2016.

You testified, and the record reflects, that your initial application was received on March 10, 2017, which resulted in you being found eligible for Medicaid, effective March 1, 2017. Therefore, even if you met the financial requirements for Medicaid during the month of November 2016, you cannot be found eligible for Medicaid during that month since it is more than three months prior to the date of your initial NYSOH application.

Accordingly, the March 11, 2017 eligibility determination notice is **AFFIRMED** insofar as you were not found eligible for retroactive Medicaid coverage during the month of November 2016.

Decision

The March 11, 2017 eligibility determination notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

You are not eligible for Medicaid in the month of November 2016.

Your eligibility for Medicaid was effective as of March 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
