Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective May 1, 2017?

Procedural History

On September 1, 2015, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective October 1, 2015.

Also on September 1, 2015, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in a Medicaid Managed Care plan, Healthfirst and that your coverage was effective October 1, 2015.

On March 1, 2017, you updated your application for financial assistance.

On March 2, 2017, NYSOH issued a notice of eligibility determination, based on your March 1, 2017 application, stating that you remained eligible for Medicaid, effective October 1, 2015.

Also on March 2, 2017, NYSOH issued a notice of enrollment in the plan you selected on March 1, 2017, Healthfirst stating that you remained enrolled in a Medicaid Managed Care plan, and that your coverage was effective October 1, 2015.

On March 28, 2017, you terminated your enrollment in your Medicaid Managed Care plan, Healthfirst, and enrolled in a new Medicaid Managed Care plan, United Healthcare.

Also on March 28, 2017, NYSOH prepared a preliminary eligibility determination stating that the enrollment start date of your Medicaid Managed Care plan, United Healthcare was May 1, 2017.

Also on March 28, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, United Healthcare insofar as it did not begin April 1, 2017.

On March 29, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in a Medicaid Managed Care plan, United Healthcare and that your enrollment start date was May 1, 2017.

On July 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the start date of your Medicaid Managed Care plan, United Healthcare.
- 2) NYSOH records reflect that you have remained enrolled in a Medicaid Managed Care plan, Healthfirst since October 1, 2015.
- 3) You testified that you called NYSOH on March 28, 2017 and cancelled your Medicaid Managed Care plan, Healthfirst.
- 4) You testified that your coverage with your Medicaid Managed Care Plan, Healthfirst ended April 30, 2017.
- 5) You testified that also on March 28, 2017 you selected your Medicaid Managed Care Plan, United Healthcare, and that your enrollment was effective on May 1, 2017.
- 6) You testified that you want your Medicaid Managed Care plan to begin on April 1, 2017 because you incurred a medical bill in the amount of \$100.00 in April 2017. You testified that you had to pay the medical cost out of pocket because your medical provider did not accept your coverage through Healthfirst.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in a Medicaid Managed Care plan, United Healthcare was effective May 1, 2017.

On September 1, 2015, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective October 1, 2015. You subsequently enrolled into a Medicaid Managed Care Plan, Healthfirst. You testified that you called NYSOH on March 28, 2017, cancelled your Medicaid Managed Care plan, Healthfirst and that the coverage end date was April 30, 2017. You testified that also on March 28, 2017 that you enrolled into a Medicaid Managed Care plan, United Healthcare.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On March 28, 2017, you selected a Medicaid Managed Care plan, United Healthcare so it properly took effect on the first day of the second following month; that is, on May 1, 2017.

Therefore, the March 29, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan, United Healthcare would be effective May 1, 2017, was correct and must be AFFIRMED.

Decision

The March 29, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan, United Healthcare is May 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
