Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective April 1, 2017?

Procedural History

On January 5, 2017, NY State of Health (NYSOH) received your application for health insurance. You also uploaded six documents to your NYSOH account on this date.

On January 6, 2017, NYSOH issued a notice stating that the income information in your application did not match what NYSOH received from state and federal data sources, and that more information was needed to confirm the information in your account. This notice directed you to submit income documentation by January 20, 2017.

On January 9, 2017, NYSOH validated your income documentation, and an updated application was submitted on your behalf.

On January 10, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in a qualified health plan at full cost, effective February 1, 2017. This notice further stated that you were not eligible for a tax credit or income-based cost-sharing reductions because you told NYSOH that you were married and planned to file taxes separately from your spouse.

On January 30, 2017, NYSOH received your updated application for health insurance.

On January 31, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in a qualified health plan at full cost, effective March 1, 2017. This notice further stated that you were not eligible for a tax credit or income-based cost-sharing reductions because you told NYSOH that you were married and planned on to file taxes separately from your spouse.

On March 3, 2017, NYSOH received your updated application for health insurance.

On March 4, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for the advanced payment of premium tax credit up to \$287.00 per month, and cost-sharing reductions if you enrolled into a silver-level qualified health plan, for a limited time, effective April 1, 2017. This notice further stated that you do not qualify to select a health plan outside of open enrollment for 2017.

On March 28, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination insofar as you were not eligible to enroll in a health plan outside of the open enrollment period.

On July 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On January 5, 2017, you submitted an application for financial assistance with health insurance.
- 2) The January 5, 2017 application indicated that your marital status was "separated", and that you planned on filing your 2017 tax return as "single".
- 3) The record indicates that you submitted six documents to your NYSOH account on January 5, 2017.
- 4) The record indicates that on January 9, 2017, NYSOH validated the income documentation on your account, updated your income, and submitted an application on your behalf.

- 5) The January 9, 2017 application indicated that your marital status was “separated”, and that you planned on filing your 2017 tax return as “single”.
- 6) The January 30, 2017 application indicated that your marital status was “separated”, and that you planned on filing your 2017 tax return as “married filing single”.
- 7) The March 3, 2017 application indicated that your marital status was “divorced”, and that you planned on filing your 2017 tax return as “single”.
- 8) You testified that you are currently married, but have been separated from your spouse for two years.
- 9) You testified that you are in the process of getting a divorce from your spouse, and are planning on being divorced by the end of 2017.
- 10) You testified that you did not enroll in a full price qualified health plan because you did not agree with your eligibility.
- 11) You testified that since filing your application on January 5, 2017, there have been no other major changes to your household.
- 12) You testified that you were misinformed by NYSOH in regards to your tax filing status.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
 - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.
- (3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.
- (4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.
- (5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual

open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days. NYSOH has not elected to adopt this subsection at this time.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective April 1, 2017.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017.

On January 10, 2017 and January 31, 2017, NYSOH issued eligibility determination notices stating that you were eligible to enroll in a full price qualified health plan. These notices further state that you were ineligible for advanced payments of premium tax credits because you were married, but indicated that you were not planning on filing your taxes with your spouse.

To be eligible for an advance premium tax credit to help pay for the cost of health insurance during the tax year, a person must attest to planning on filing a tax return. Most married individuals must file a joint return with their spouse in order to qualify for an advance premium tax credit.

You testified that you are currently separated from your spouse, and have been for two years. You testified that you are planning on getting a divorce from your spouse by the end of 2017. You testified that you did not enroll into a qualified health plan before the end of open enrollment because you did not agree with your eligibility determination.

On March 3, 2017, you submitted an application for health insurance. On this application, you indicated that you were divorced, and planned on filing your 2017 tax return as single. As a result, you were found eligible for advanced payment of the premium tax credits. On March 4, 2017, NYSOH issued a notice stating that you do not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified that you applied for health insurance through NYSOH in early January. You testified that you were given wrong information by the NYSOH representatives in regards to your tax filing status, which kept you from being found eligible for financial assistance with your health insurance. You further testified that you did not enroll into a qualified health plan during open enrollment because you did not agree with your eligibility.

The record indicates that you were found eligible for a full price qualified health plan before the open enrollment period ended, and could have enrolled into a qualified health plan, but you chose not to do so due to the fact that you were not eligible for financial assistance.

Therefore, you did not adequately demonstrate that your non-enrollment into a qualified health plan was due to misinformation by NYSOH because you were eligible for and able to enroll into a qualified health plan prior to the open enrollment period ended, but chose not to do so.

Since the record does not indicate that NYSOH, by action or inaction, made an error or misrepresented information that kept you from enrolling into a qualified health plan, a special enrollment period cannot be granted.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's March 4, 2017 eligibility determination that you do not qualify to select a health plan outside of the open enrollment period for 2017 is **AFFIRMED**.

Decision

The March 4, 2017 eligibility determination is **AFFIRMED**.

Effective Date of this Decision: July 24, 2017

How this Decision Affects Your Eligibility

You do not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
