lssue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your and your spouse's enrollment in a qualified health plan and the application of advance payments of the premium tax credit were effective no earlier than May 1, 2017?

Procedural History

On March 11, 2017, NYSOH issued a notice of eligibility redetermination based on your March 10, 2017 application stating that you and your spouse were eligible to receive up to \$642.00 per month in advance payments of the premium tax credits (APTC) and, if you selected a silver-level qualified health plan, for cost-sharing reductions (CSR). This eligibility was effective April 1, 2017.

On March 11, 2017, NYSOH issued a notice stating that action was required because you needed to pick a health plan and your coverage with a qualified health plan would not begin until you pick a plan.

On March 24, 2017, NYSOH issued a letter confirming your and your spouse's enrollment in a qualified health plan, with a monthly premium responsibility of \$302.96, after your APTC of \$642.00 was applied, both effective May 1, 2017.

On March 29, 2017, you spoke to NYSOH's Account Review Unit and appealed the enrollment confirmation notice insofar as it began your enrollment in a qualified health plan on May 1, 2017, and not April 1, 2017.

On July 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on March 10, 2017.
- 2) You testified, and the record reflects, that you first selected a qualified health plan on March 23, 2017.
- 3) Your and your spouse's enrollment in the qualified health plan became effective May 1, 2017.
- 4) You testified that you want your qualified health plan to begin on April 1, 2017 because you are concerned about having a gap in coverage and being responsible for a tax penalty for being without insurance for 2017.
- 5) You testified you did not realize you had to select a health plan on March 10, 2017, the day you were determined eligible for APTC.
- 6) You testified you and your spouse did not incur medical bills for the month of March, 2017.
- 7) You reside in , NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Redetermination During a Benefit Year

When a redetermination is issued as a result of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be that any change made after the 15th of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

When an eligibility redetermination results in a change in the amount of advance payments of the premium tax credit (APTC) for the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for that benefit year (45 CFR § 155.330(g)).

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your and your spouse's enrollment in a qualified health plan, as well as the application of APTC, was effective no earlier than May 1, 2017.

The record shows that March 10, 2017 you updated the information in your NYSOH account and were determined eligible for APTC and to enroll in a qualified health plan effective April 1, 2017. On March 11, 2017, NYSOH issued an enrollment confirmation notice stating action was required, and that you needed to pick a health plan or your enrollment would not begin.

The record supports you then chose a health plan on March 23, 2017. An enrollment confirmation notice was issued on March 24, 2017 stating that your and your spouse's enrollment in your qualified health plan was effective May 1, 2017 and that APTC would be applied to your monthly premium effective May 1, 2017.

When an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the change effective the first day of the following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. A Plan that is selected after the 15th of the month goes into effect on the first day of the first day of the following month.

Since you selected a plan for enrollment on March 23, 2017, your and your spouse's enrollment would begin on the first day of the second following month after March, that is May 1, 2017.

Therefore, since NYSOH's March 24, 2017, enrollment notice properly stated you and your spouse's enrollment in a qualified health plan as well as the application of your APTC were effective May 1, 2017, it is correct and is AFFIRMED.

Decision

The March 24, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your and your spouse's enrollment in your qualified health plan, and your application of APTC properly began as of May 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
