Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's enrollment in their Child Health Plus plan should be effective April 1, 2017?

Procedural History

On February 27, 2017, an application for financial assistance was submitted for your child.

On February 28, 2017, NYSOH issued an eligibility determination notice stating in part that your child was eligible for Child Health Plus with a monthly premium of \$9.00 for a limited time, effective April 1, 2017. The notice stated that additional proof of income was needed by April 28, 2017, to confirm your child's eligibility.

On March 30, 2017, NYSOH issued a plan enrollment notice confirming in part that, on March 29, 2017, your child was enrolled in a Child Health Plus plan with an enrollment start date of April 1, 2017.

Also on March 30, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the enrollment start date of your child's health insurance.

On July 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the plan enrollment start date of your child's Child Health Plus plan.
- 2) You testified you received a notice from ██████ County Local Department of Social Services (LDSS) in February 2017 stating that your child was not eligible for Medicaid.
- 3) You testified that you applied for health insurance for your child in the month of February 2017, because they were no longer eligible for health insurance through ██████ County LDSS.
- 4) According to the "Appeal Summary" in the Evidence Packet was created in anticipation of your telephone hearing:

On 02/27/2017 [your child] was determined eligible for CHP with a \$9.00 premium per month. However[,] due to Defect ██████ ██████ prevented the plan selection on this day. Defect was resolved on 03/29/2017

(see Document ██████; ID# ██████).

- 5) According to your NYSOH account and testimony, you selected a Child Health Plus plan for your child on March 29, 2017, and their Child Health Plus plan enrollment was effective as of April 1, 2017.
- 6) You testified that you want your child's health plan to be effective February 1, 2017, to cover the medical expenses that you incurred in that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child’s Child Health Plus plan enrollment start date was April 1, 2017.

You testified that you applied for health insurance through NYSOH for your child in the month of February 2017, because they were no longer eligible for health insurance through ██████ County LDSS.

The record reflects that your child was determined eligible for Child Health Plus on February 27, 2017; however, due to a system defect, you were unable to enroll your child in a health plan on that date. The system defect was resolved on March 29, 2017, and your child was enrolled in a health plan effective April 1, 2017.

Generally, the date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the

following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

According to your NYSOH account and testimony, had the system defect not occurred, the earliest your child would have enrolled in a health plan was on February 27, 2017. Therefore, your child's enrollment in their Child Health Plus plan would have properly been effectuated the first day of the second month following February 27, 2017; that is, on April 1, 2017.

Therefore, since the March 30, 2017 plan enrollment notice confirming that your child was enrolled in a Child Health Plus plan with a plan enrollment start date of April 1, 2017 was correct, it must be AFFIRMED.

Decision

The March 30, 2017 plan enrollment notice is AFFIRMED.

Effective Date of this Decision: July 26, 2017

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility or enrollment.

The effective enrollment start date of your child's Child Health Plus plan is April 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
