Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child was not eligible for Child Health Plus (CHP), as of May 1, 2017, because [REDACTED] was enrolled in third party health insurance?

Procedural History

On March 30, 2017, NYSOH prepared a preliminary eligibility determination finding your child was eligible to enroll in a full price qualified health plan and ineligible for CHP, effective May 1, 2017.

Also on March 30, 2017, you spoke to NYSOH's Account Review Unit and appealed the preliminary determination insofar as your child was not eligible for CHP.

On March 31, 2017, NYSOH issued an eligibility determination notice, based on your child's March 30, 2017 updated application, stating that your child was eligible to enroll in a full price qualified health plan, effective May 1, 2017. The notice further stated that your child does not qualify for CHP because federal and state data sources show [REDACTED] is already enrolled in or eligible for a public insurance program such as Tricare.

On July 17, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that, when you initially appealed, you were seeking your child reinstated in [REDACTED] CHP plan. This was because the health insurance provided by the Veteran's Administration does not provide sufficient coverage for your child and many doctors will not accept it.
- 2) You testified that your child will be moving to [REDACTED] to live with [REDACTED] in August 2017 and no longer needs health insurance. You want to continue with the appeal to advocate for your fellow soldiers.
- 3) On March 23, 2017, you updated your child's application and [REDACTED] was found to be ineligible for CHP as of May 1, 2017, because federal and state data sources showed that [REDACTED] had Third Party Health Insurance through Tricare.
- 4) You testified that you attempted to disenroll your child from Tricare, but were unable to do so. Your child, who is currently [REDACTED] [REDACTED] old, is covered by Tricare until [REDACTED] turns 21 years old.
- 5) You testified that it is unfair that individuals who serve our country are limited to an inferior and more expensive form of health insurance than those who never worked or served our country.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (PHL) § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;

- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(N.Y. Pub. Health Law. § 2511(2)(a)-(e)).

Legal Analysis

The issue under review is whether NYSOH properly determined that that your child was not eligible for CHP, as of May 1, 2017, because [REDACTED] had other health insurance coverage.

On March 23, 2017, you updated your child's application and [REDACTED] was found to be ineligible for CHP as of May 1, 2017, because federal and state data sources showed that [REDACTED] was enrolled in other health insurance through Tricare.

You testified that, at the time of your March 30, 2017 application, your child was covered by Tricare. In fact, you testified that you attempted to disenroll [REDACTED] from Tricare, but were unable to do so because your child, who is [REDACTED] [REDACTED] old, remains covered by Tricare until [REDACTED] turns 21 years old.

However, you further testified that Tricare does not provide sufficient coverage for your child and many doctors will not accept it.

Notwithstanding your complaint, one of the conditions under the law for a child to be eligible for CHP through NYSOH is that he or she must not have other health insurance coverage. As such, when NYSOH determines that a child has active coverage in a health insurance plan outside of NYSOH, he or she will not be eligible to enroll in a CHP plan.

Since, the credible evidence of record shows that your child was enrolled in Tricare at the time of your application for CHP and will continue to be enrolled in Tricare until [REDACTED] turns 21 years old, NYSOH properly determined that your child was ineligible for CHP, effective May 1, 2017.

Therefore, NYSOH's March 31, 2017 eligibility determination notice is correct and is AFFIRMED.

Decision

The March 31, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your child is not eligible for CHP through NYSOH because [REDACTED] is enrolled in other health insurance coverage.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
