Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your parents were eligible to enroll in the Essential Plan, effective April 1, 2017, and not eligible for Medicaid?

Procedural History

On March 30, 2017, NYSOH received your updated application for health insurance. That day, a preliminary eligibility determination was prepared stating that your parents were eligible for the Essential Plan.

Also on March 30, 2017, you spoke to NYSOH's Account Review Unit and appealed the preliminary eligibility determination, insofar as your parents were not eligible for Medicaid.

On March 31, 2017, NYSOH issued a notice of eligibility determination, stating that your parents were eligible to enroll in the Essential Plan, with no monthly premium, effective April 1, 2017. They qualified for the Essential Plan because your household income was less than the allowable income limit and they were in the first five years of their qualified immigration status or your parents are living in the United States under the color of law.

On July 13, 2017, your authorized representative, [REDACTED], had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The

record was developed during the hearing and held open up to July 28, 2017, to allow you to submit supporting documents.

Also on July 13, 2017, NYSOH received your documentation and it was incorporated into the record as "Appellant's Exhibit #1." The record was closed that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You are seeking insurance for your parents.
- 2) Your application states that you will be filing taxes with a filing status of married filing jointly and claiming your two children and your two parents as dependents on your tax return.
- 3) Your application states that your parents will not be filing taxes.
- 4) Your authorized representative testified that your parents have valid permanent resident cards.
- 5) Your parent's immigration documentation was uploaded into your account on July 13, 2017. Your mother has a status of [REDACTED], which means that she is the sister of a US citizen, and your father has a status of [REDACTED], which means he is the spouse of an alien classified as [REDACTED].
- 6) Your authorized representative testified, and the record reflects, that your parents obtained permanent resident status on January 12, 2017.
- 7) The application that was submitted on March 30, 2017, which requested financial assistance, listed annual household income of \$26,000.00.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-

citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$32,580.00 for a six-person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

Medicaid

A person who meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard is eligible for Medicaid benefits (45 CFR § 155.305(c)). One of the non-financial criteria for Medicaid eligibility is the immigration status of the person applying for health insurance. A person is eligible for Medicaid when his or her immigration status is satisfactory and he or she meets all other requirements for Medicaid (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$32,960.00 for a six-person household (82 Fed. Reg. 8831).

Qualified Immigrants

In NY State, qualified immigrants who were formerly eligible for Medicaid through the state, but not eligible for Medicaid under federal law, were transitioned to the Essential Plan as of January 1, 2016 (New York's Basic Health Plan Blueprint, p. 19, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>). This category of qualified immigrants includes individuals lawfully admitted for permanent residence in the United States who are still in their first five years of permanent residency. (18 NYCRR § 349.3, 8 USC § 1613).

Legal Analysis

The issue under review is whether NYSOH properly determined that your parents were eligible to enroll in the Essential Plan, effective April 1, 2017, and not eligible for Medicaid.

The application that was submitted on March 30, 2017 listed an annual household income of \$26,000.00 and the eligibility determination relied upon that information.

According to your application, your parents are in a six-person household. You expect to file your 2017 income taxes as married filing jointly and will claim your two parents and two children as dependents.

The Essential Plan is provided through NYSOH to individuals who are lawfully present non-citizens who are ineligible for Medicaid or Child Health Plus as a result of their immigration status, and have a household income that is between 0% and 200% of the FPL. Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size.

On the date of your application, the relevant FPL was \$32,580.00 for a six-person household. Since an annual income of \$26,000.00 is 79.80% of the 2016 FPL and 78.88% of the 2017 FPL, your household meets the financial eligibility criteria for both the Essential Plan and Medicaid.

However, your representative testified that your parents are permanent residents, and have had permanent resident status since January 12, 2017. As of January 1, 2016, legal permanent residents who were receiving Medicaid through NY State, but were not eligible for Medicaid under federal law due to being in the first five years of their permanent residency, must now receive coverage through the Essential Plan. Therefore, because your parents are in their first five years of permanent residency, NYSOH properly determined that they do not meet the non-financial requirements for Medicaid.

Since your parents meet the non-financial and financial requirements for the Essential Plan, NYSOH properly determined you to be eligible for Essential Plan coverage.

Therefore, since the March 31, 2017, eligibility determination properly stated that, based on the information you provided, your parents were eligible for the Essential Plan effective April 1, 2017, it was correct and is AFFIRMED.

Decision

The March 31, 2017 eligibility determination is AFFIRMED.

How this Decision Affects Your Eligibility

Your parents remain eligible for the Essential Plan.

Your parents are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
