## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On April 1, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective May 1, 2017. You appealed this determination.

On June 9, 2017, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for July 19, 2017, at 1:00 p.m.

On July 19, 2017, a Hearing Officer called and spoke with you. You indicated you were not sure if you wanted to proceed with the hearing and requested an adjournment to conduct some research to determine whether you wanted to proceed with the appeal or accept the new eligibility determination. The Hearing Officer agreed to adjourn the hearing and advised you that the hearing would be rescheduled to August 3, 2017 at 3:00 p.m. You agreed to the rescheduled hearing date and time.

On August 3, 2017, a Hearing Officer placed three calls to the telephone number you provided to NYSOH, at 3:00 p.m., 3:15 p.m., and 3:30 p.m., but was unable to reach you.

Since you did not appear for your adjourned hearing, we are dismissing your appeal.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
