Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended, effective March 31, 2017?

Did NYSOH properly determine that your eligibility for and enrollment in the Essential Plan was effective May 1, 2017?

Procedural History

On December 10, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, effective January 1, 2017. The notice further directed you to provide documentation confirming your income before March 9, 2017.

Also on December 10, 2016, NYSOH issued a notice confirming your enrollment in an Essential Plan, beginning February 1, 2016.

On March 16, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective April 1, 2017.

Also on March 16, 2017, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of March 31, 2017, because you were no longer eligible to remain in your plan.

On March 21, 2017, you updated your application for financial assistance.

On March 22, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective May 1, 2017.

Also on March 22, 2017, NYSOH issue a notice of enrollment confirmation, based on your plan selection on March 21, 2017, stating that you were enrolled in an Essential Plan, beginning May 1, 2017.

On April 5, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan coverage for the month of April 2017.

On July 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your application indicates, that you receive all of your notices from NYSOH via regular mail.
- 2) You testified that you did not recall whether you received any notices stating that your eligibility was only conditional, and that you needed to provide documentation of your household's income.
- 3) No notices that were sent to the address listed on your NYSOH account have been returned as undeliverable.
- 4) You testified that you updated your account in December 2016 through a broker. You testified that the broker told you that you needed to submit income documentation for your application.
- 5) You testified that you contacted your accountant and that your accountant emailed you your income documentation.
- 6) You testified that you thought you forwarded that email to your broker, but you are not positive that you actually did so. You testified that it

was also possible that you forwarded it, but that it did not go through, or bounced back to you.

- 7) You testified that you did not follow up with your broker after completing your application.
- 8) You testified that you then received two notices from NYSOH, and one of them said your coverage was ending at the end of March 2017. You testified that you contacted NYSOH and updated your application, and thought that everything was resolved, and that there would be no gap in your coverage.
- 9) Your NYSOH account confirms that your application was updated on March 21, 2017.
- 10) You testified that you then received a bill for copays for some lab work, and you called NYSOH to find out why you were being billed.
- 11) You testified that, during that phone call, you found out there was a gap in your coverage for the month of April 2017, and so you filed an appeal.
- 12) You testified that you do not have any medical bills for the month of April 2017, but would like your coverage reinstated for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the federal poverty level, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); see also 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); see also 42 CFR § 600.320(c)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended, effective March 31, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on December 10, 2016, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before March 9, 2017.

You testified that you did not recall whether you received any notice from NYSOH telling you that you needed to provide income documentation to confirm your eligibility. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. There is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, NYSOH properly notified you of an inconsistency in your account and that documentation was needed to confirm the income you listed in the account.

You testified that you updated your application in December 2016 with the assistance of a broker, and that he asked you to submit some income documentation. You testified that you asked your accountant to send you your tax information, and your accountant emailed that documentation to you. You testified that you thought you forwarded it to your broker, but that you either forgot to, or the email did not go through. There is no indication in your NYSOH account that any income documentation was ever submitted to NYSOH.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation.

Accordingly, your eligibility for the Essential Plan terminated as of March 31, 2017 because you did not submit documentation and did not adequately demonstrate that you could not provide documentation to confirm your income.

Therefore, the March 16, 2017 eligibility determination notice is AFFIRMED.

The second issue under review is whether NYSOH properly determined that your eligibility for, and enrollment in, the Essential Plan began effective May 1, 2017.

Your NYSOH account reflects that you updated your NYSOH application on March 21, 2017. That day, you selected an Essential Plan for enrollment.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to, and including, the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected between the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected an Essential Plan on March 21, 2017, your enrollment would properly take effect on the first day of the second month following March; that is, on May 1, 2017.

Therefore, the March 22, 2017 eligibility determination and enrollment confirmation notices, stating that your enrollment in the Essential Plan was effective May 1, 2017, are correct and must be AFFIRMED.

Decision

The March 16, 2017 notice of eligibility determination is AFFIRMED.

The March 22, 2017 notice of eligibility determination is AFFIRMED.

The March 22, 2017 notice of enrollment confirmation is AFFIRMED.

How this Decision Affects Your Eligibility

NYSOH properly found you not eligible to enroll in the Essential Plan, effective April 1, 2017, because you did not provide documentation of your household's income.

NYSOH properly found that your reenrollment in the Essential Plan was effective May 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
