Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for the Essential Plan?

Did NY State of Health properly determine that you were ineligible for Medicaid?

Procedural History

On February 28, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On March 1, 2017, NYSOH issued a notice stating that the income information in your application did not match what NYSOH received from state and federal data sources, and that more information was needed to confirm the information in your application. This notice further directed you to submit income documentation by March 15, 2017.

On March 11, 2017, you uploaded one document to your NYSOH account.

On March 22, 2017, NYSOH validated your income documentation and updated your application for financial assistance with health insurance.

On March 23, 2017, NYSOH issued an eligibility determination stating that you were eligible for the Essential Plan with a \$20.00 monthly premium, effective

May 1, 2017. This notice also stated that you were not eligible for Medicaid because your income was over the allowable income limit for that program.

On April 6, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as you were not found eligible for Medicaid.

On April 11, 2017, NYSOH issued an eligibility determination stating that you were eligible for Medicaid, for a limited time, effective April 1, 2017. This notice further stated that you had been granted Aid to Continue until a decision was made on your appeal.

Also on April 11, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a Medicaid Managed Care plan, effective April 1, 2017.

On July 26, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was left open to August 10, 2017, to allow you to submit supporting documents.

As of the close of business day on August 10, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You are seeking insurance for yourself.
- 2) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 3) The application that was submitted on February 28, 2017 listed annual household income of \$14,560.00, consisting of income you earn from your employment.
- 4) On March 11, 2017, you uploaded a letter from your employer, dated March 7, 2017, which stated that you make \$11.00 an hour and work a minimum of 40 hours a week.
- 5) On March 22, 2017, NYSOH validated the letter from your employer and changed your annual expected household income from \$14,560.00 to \$22,880.00.

- 6) You testified that your annual expected household income is \$22,880.00, but that is before taxes.
- 7) You testified that you believe that NYSOH should not use your gross income, but that NYSOH should use your income after taxes because that is indicative of what your income actually is.
- 8) You testified that you could not answer the question of what your monthly income for March 2017 was.
- 9) Your application states that you will not be taking any deductions on your 2017 tax return.
- 10) Your application states, and your confirmed, that you live in Bronx County.
- 11) You further testified that you cannot afford to pay for your health insurance after you pay your rent, and other monthly bills, and that you believe these expenses should be taken into account.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11.880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one -person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective May 1, 2017.

The application that was submitted on March 22, 2017 listed an annual expected household income of \$22,880.00.

During the hearing, you testified that you think that NYSOH should use your taxed income and not your gross income when determining your eligibility. You further testified that the amount that was provided in your application was correct. However, you asked that your current expenses, which include rent, other monthly expenses be considered when calculating your annual household income.

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code. "Adjusted gross income" means the gross federal taxable income minus certain deductions. Further since the Internal Revenue Service rules do not allow living expenses such as rent, utilities, cable and phone to be deducted from the calculation of your adjusted gross income, they cannot be deducted when the NYSOH computes your modified adjusted gross income for APTC purposes. Therefore, NYSOH correctly determined your household income to be \$22,880.00.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$22,880.00 is 192.59% of the 2016 FPL, NYSOH properly found you eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable

family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$22,880.00 is 189.72% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

The Hearing Officer left the record open until August 10, 2017 to allow you time to submit income documentation for the month of March 2017. However, by the end of the business day on August 10, 2017, there was no income documentation received by NYSOH's Appeals Unit, nor were there any income documents viewable on your NYSOH account.

Since there is no other reliable income documentation indicating the amount you earned in March 2017 in the record, NYSOH's Appeals Unit must rely on the record as it was developed during the hearing.

Since the March 23, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

Decision

The March 23, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for the Essential Plan.

You are ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
