## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On March 21, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were newly eligible to enroll in a full cost qualified health plan, effective May 1, 2017. You appealed that determination.

On July 20, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your tax credit and enrollment in a health plan have since been reinstated as of July 1, 2017, and you are not looking to retroactively enroll in coverage for the two months when you were eligible for a full cost health plan.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
