NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On April 11, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for advance payment of the premium tax credit up to \$237.00 per month for a limited time, and eligible for cost sharing reductions if you enrolled in a Silver level qualified health plan, effective May 1, 2017. Your child was eligible for Child Health Plus for a cost of \$9.00 per month for a limited time, effective May 1, 2017. The determination stated you needed to provide proof of your income by April 24, 2017, and your child's by June 2, 2017. You appealed this determination.

On June 16, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 20, 2017, at 10:00 a.m.

On July 20, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 10:00 a.m., 10:15 a.m., and 10:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
