## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your spouse were eligible for the Essential Plan, with a \$20 per month premium each?

## Procedural History

On April 14, 2017, you updated your application for financial assistance for you and your spouse. That day, a preliminary eligibility determination was prepared finding you and your spouse eligible for the Essential Plan, with a \$20.00 premium per month each, effective May 1, 2017.

Also on April 14, 2017, you spoke to NYSOH's Account Review Unit and appealed your and your spouse's eligibility for the Essential Plan with a premium of \$20.00 per month each.

On April 15, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse were eligible for the Essential Plan for a limited time with a \$20.00 premium per month each, effective May 1, 2017.

On July 27, 2017, you failed to appear at a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit and your appeal was dismissed at that time. On August 3, 2017, you submitted a request to vacate the dismissal for good cause. On August 8, 2017, your request was granted and the dismissal was vacated and a new hearing was scheduled.

On August 29, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeal's Unit. The record was developed during the hearing and closed at the end of the hearing

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim two dependents on that tax return.
- 2) You are seeking insurance for yourself and your spouse.
- 3) The application that was submitted on April 14, 2017 listed annual household income of \$38,488.00, consisting of \$1,152.00 you earned from your employment and \$37,336.00 your spouse receives from his employment. You testified that this amount was correct at the time and has not changed.
- 4) Your application states and you testified that you and your spouse will not be taking any deductions on your 2017 tax return.
- 5) Your application states and you testified, that you and your spouse live in [REDACTED]
- 6) You testified that you would like to be considered for the Essential Plan with a \$0.00 monthly premium for you and your spouse.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR

§ 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$24,300.00 for a four-person household (81 Federal Register 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you and your spouse were eligible for the Essential Plan with a \$20.00 per month premium each, effective May 1, 2017.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$24,300.00 for a four-person household. Since an annual household income of \$38,488.00 is 158.39% of the 2016 FPL, NYSOH properly found you and your spouse to be eligible for the Essential Plan.

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution. Since your household income of \$38,488.00 is 158.39% of the 2016 FPL, NYSOH properly found that you and your spouse were responsible for a \$20.00 per month premium each.

Since the April 15, 2017 eligibility determination notice properly stated that, based on the information you provided, you and your spouse were eligible for the

Essential Plan with a \$20.00 per month premium each, it is correct and is AFFIRMED.

## **Decision**

The April 15, 2017 eligibility determination notice is AFFIRMED.

This decision has no effect on any subsequent eligibility determination notices issued by NYSOH.

## **How this Decision Affects Your Eligibility**

You and your spouse are eligible for the Essential Plan with a \$20.00 per month premium each as of May 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
