NOTICE OF DISMISSAL

On March 22, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible for the Essential Plan, effective May 1, 2017. You appealed this determination.

On June 16, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 20, 2017, at 11:00 a.m.

On July 20, 2017, a Hearing Officer called at 11:00 a.m. and left a message that he would call again at 11:10 a.m. The Hearing Officer then called at 11:10 a.m. using the services of a [REDACTED] interpreter. Your spouse answered the phone and identified himself. Through the interpreter, your spouse stated that the appeal was no longer necessary. The Hearing Officer then attempted to place your spouse under oath so he could formally state that the appeal was withdrawn. Prior to being placed under oath, your spouse terminated the call.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
