Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid through NYSOH, effective April 1, 2017?

Procedural History

On January 24, 2017, NYSOH issued an eligibility determination, stating that you remained eligible for Medicaid, effective January 1, 2017.

Also on January 24, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in a Medicaid Managed Care plan, effective October 1, 2015.

On February 17, 2017, an application for financial assistance with health insurance was run on your behalf.

On February 18, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost through NYSOH, effective April 1, 2017. The notice further stated that this was because federal and state data sources showed that you were already enrolled in Medicaid, Child Health Plus, or another program.

Also on February 18, 2017, NYSOH issued a disenrollment notice, stating that your Medicaid Managed Care Plan through NYSOH would end March 31, 2017.

On March 9, 2017, NYSOH received your updated application for financial assistance with health insurance.

On March 10, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost through NYSOH, effective April 1, 2017. The notice further stated that this was because federal and state data sources showed that you were already enrolled in Medicaid, Child Health Plus, or another program.

On April 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the determination, insofar as you were not determined eligible for Medicaid through NYSOH as of April 1, 2017.

On August 1, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking enrollment in a Medicaid Managed Care plan through NYSOH for April 2017.
- 2) You testified that you have no income, and do not plan on filing a tax return.
- 3) You testified that you previously had Medicaid coverage through NYSOH, and that your coverage through NYSOH ended on March 31, 2017.
- 4) You testified that a health plan representative referred you to your local Human Resource Administration when you recertified for coverage.
- 5) Information contained in the system shows that you have coverage through the Local Department of Social Services or NYC Human Resources Administration, effective April 1, 2017. You testified that this is correct.
- 6) You testified that your Medicaid Managed Care plan enrollment through your local Human Resources Administration was effective May 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if that individual was eligible at any time during that month (42 CFR § 435.915(b); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue for review is whether NYSOH properly determined that you were not eligible for Medicaid through NYSOH, effective April 1, 2017.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size.

Individuals who are otherwise eligible for and enrolled in mandatory Medicaid coverage outside of NYSOH are not eligible for Medicaid coverage through NYSOH.

In the present instance, you are enrolled in Medicaid through your Local Department of Social Services or NYC Human Resources Administration, with an [REDACTED] start date. As such, you are not eligible for Medicaid through NYSOH.

Therefore, the March 10, 2017 eligibility determination stating that you are not eligible for Medicaid through NYSOH is AFFIRMED.

NYSOH and the Local Department of Social Services or NYC Human Resources Administration are two separate and distinct entities. A finding that you are not eligible for Medicaid through NYSOH, has no bearing on your eligibility through your Local Department of Social Services or NYC Human Resources Administration.

If there is an issue with your coverage, you will need to contact your Local Department of Social Services or NYC Human Resources Administration for assistance.

Decision

The March 10, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You are not eligible for Medicaid through NYSOH for [REDACTED], because the system shows that you had Medicaid through your Local Department of Social Services or NYC Human Resources Administration.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
