NOTICE OF DISMISSAL – INVALID APPEAL REQUEST

On February 11, 2016, NY State of Health (NYSOH) issued an eligibility determination notice stating, in relevant part, that you [REDACTED] were eligible to enroll in the Essential Plan, effective March 1, 2016.

Also on February 11, 2016, NYSOH issued a plan enrollment notice confirming that as of February 10, 2016, you were enrolled in an Essential Plan 1 (Healthfirst) with an enrollment start date of January 1, 2016.

On September 19, 2016, NYSOH issued an eligibility determination notice stating, in relevant part, that you were newly eligible to purchase a qualified health plan at full cost through NYSOH, effective November 1, 2016. The notice stated that you were not eligible for the Essential Plan because you did not submit the income documentation needed to verify the income listed in your application.

On September 19, 2016, NYSOH issued a disenrollment notice stating that your Essential Plan 1 coverage would end October 31, 2016, because you were no longer eligible to remain enrolled in your current health insurance.

On April 18, 2017, you spoke to NYSOH's Account Review Unit and requested an appeal seeking payment for the outstanding medical bills for medical services received during the month of April 2016.

On August 1, 2017, you had a telephone hearing, with the assistance of Spanish interpreter [REDACTED] with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was left open until August 2, 2017, to allow you to submit your outstanding bills for the month of April 2016.

On August 2, 2017, you faxed two-pages of documentation to NYSOH Appeals Unit, consisting of your outstanding medical bills for the medical services received in April 2016.

Why Your Appeal Request Is Not Valid

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

You testified that you began to receive medical bills in March 2017 for medical services that were performed in April 2016. Furthermore, you contacted Healthfirst and were informed that you were not in their computer system. The enrollment history in your NYSOH account reflects that you were enrolled in an Essential Plan 1, through Healthfirst, from March 1, 2016 through October 31, 2016.

Your appeal request disputes the fact that you have incurred medical bills from the medical services performed in April 2016, even though you were enrolled in an Essential Plan. This is a health plan billing issue, which is not an issue that the Appeals Unit of NYSOH is authorized to address. Therefore, we must dismiss your appeal.

However, your case is RETURNED to NYSOH's Plan Management to further investigate whether you were enrolled in health coverage in April 2016 through NYSOH. If you were enrolled in health coverage for that period, they shall coordinate with the health insurance company to ascertain whether the medical services should have been covered by the health insurance plan.

How does this Dismissal Affect Your Eligibility?

This decision does not change your eligibility for or enrollment in health insurance through NYSOH.

You may have recourse outside of the Appeals Unit of NYSOH, such as through your health plan or through the Department of Financial Services.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated and if your issue differs from the one discussed above.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.

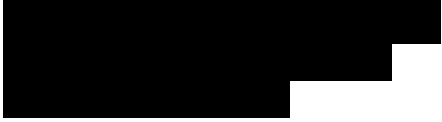
