NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On February 19, 2017, NY State of Health (NYSOH) issued a disenrollment notice stating that your children's coverage had been terminated for non-payment of premiums, effective February 1, 2017. On April 21, 2017, NYSOH issued an eligibility determination notice stating that your children were eligible for Child Health Plus (CHP) with a \$60.00 monthly premium each, effective May 1, 2017. You appealed these determinations.

On August 3, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because (1) you did not incur any out-of-pocket medical expenses for your children's coverage during the months of May and June 2016 when they were enrolled in their CHP plan rather than your platinum-level qualified health plan and (2) you believed that your children were enrolled in a health plan outside of NYSOH between January 1, 2017 and April 30, 2017, which would obviate any tax liability on your part for the 2017 plan year. You further testified that you would follow up with NYSOH when then 1095A was issued for the 2017 plan year to resolve any discrepancies in your children's coverage at that time.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
