Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children's enrollment in their Child Health Plus (CHP) plan was effective May 1, 2017?

Procedural History

On March 25, 2017, NYSOH issued a notice of eligibility determination, based on your March 24, 2017 application, stating that your children were eligible to enroll in CHP with a \$15.00 monthly premium each for a limited time, effective May 1, 2017.

Also on March 25, 2017, NYSOH issued a notice of enrollment, based on your plan selection on March 24, 2017, stating that your children were enrolled in a CHP plan, and that this enrollment would start on May 1, 2017.

On April 20, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's CHP plan, insofar as it did not begin April 1, 2017.

On August 4, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified that you are appealing only your son's enrollment start date.
- 2) You testified that your children were previously covered on your employer's health insurance plan, but that, in late March 2017, your employer informed you that they would no longer be offering coverage for your children.
- 3) You testified that you immediately contacted NYSOH to enroll your children in health insurance.
- 4) You submitted an application to NYSOH for financial assistance on March 24, 2017
- 5) The record reflects that you enrolled your children into a CHP plan on March 24, 2017, and you confirmed in your testimony that you enrolled your children in a plan toward the end of March 2017.
- 6) You testified that you were aware that your children's coverage would not start until May 1, 2017, and you were willing to accept that, initially.
- 7) You testified that your son subsequently became [REDACTED] and had to be hospitalized in [REDACTED] 2017.
- 8) You testified that you have a \$13,000.00 hospital bill for your son, as well as other medical bills for him, all from the month of April 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for CHP is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [CHP], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [CHP] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for CHP begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children’s enrollment in their CHP plan began on May 1, 2017.

You testified that you contacted NYSOH on March 24, 2017, and enrolled your children into a CHP plan, and your NYSOH account confirms this.

The date on which a CHP plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Though you credibly testified that you enrolled your children in coverage as soon as you found out that their employer-sponsored coverage was ending, there is no provision in the law that would allow the backdating of your children’s coverage on this basis.

Therefore, the March 25, 2017 eligibility determination and enrollment confirmation notices stating that your children’s eligibility for, and enrollment in, their CHP plan was effective May 1, 2017, are correct and must be **AFFIRMED**.

Decision

The March 25, 2017 eligibility determination notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's CHP coverage and enrollment was May 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
