NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On June 2, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming your selection of a qualified health plan (QHP) as of June 1, 2017. This notice stated that your QHP coverage would begin effective June 1, 2017. You appealed insofar as you were seeking for such coverage to begin no later than May 1, 2017.

On August 2, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you and your spouse, acting as your Authorized Representative, under oath.

While under oath, your spouse identified himself and stated that you were no longer interested in pursuing your appeal because you did not incur medical expenses exceeding the premium cost that would have been due for coverage during the month of May 2017 if you prevailed in your appeal.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
