## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$250.00 per month in advance payments of the premium tax credit (APTC), as of April 26, 2017?

Did NYSOH properly determine you eligible for cost-sharing reductions (CSR), as of April 26, 2017?

Did NYSOH properly determine that you were ineligible for Medicaid as of April 26, 2017?

## Procedural History

On April 25, 2017, you submitted an application for financial assistance through NYSOH. Based on that application, NYSOH rendered a preliminary eligibility determination finding you eligible for up to \$250.00 of APTC and CSR

Also on April 25, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as you were not eligible Medicaid.

On April 26, 2017, NYSOH issued an eligibility determination notice stating, in relevant part, that you were eligible for a tax credit up to \$250.00 per month and CSR, effective as of June 1, 2017. Furthermore, the notice stated that you were ineligible for Medicaid because the household income you attested to was over the allowable income limit for that program.

On May 6, 2017, NYSOH issued a notice stating that you were eligible for Medicaid for a limited time, effective June 1, 2017. You had been granted Aid to Continue until a decision is made on your appeal.

On August 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and testimony, you are applying for health insurance for yourself.
- 2) According to your April 25, 2017 application, you attested to filing your 2017 federal income tax return with the tax status of married filing jointly and did not expect to claim any dependents on that tax return.
- 3) You testified that you were not certain if you would be filing a joint return with your spouse in 2017.
- 4) You testified that you currently reside with your spouse.
- 5) According to your April 25, 2017 application, you attested to an annual household income of \$34,956.00. You are issued \$1,121.00 monthly in Social Security benefits, and your spouse is issued \$1,792.00 in Social Security benefits.
- 6) According to your NYSOH account and testimony, you do not expect to claim any deductions on your 2017 federal income tax return.
- 7) According to your account, you reside in [REDACTED], New York.
- 8) You testified that you are unable to afford health insurance because of your monthly expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## Applicable Law and Regulations

### Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

### Household Composition

For purposes of advance premium tax credit (APTC) and cost-sharing reductions (CSR), the household size equals the number of individuals for whom the taxpayer is allowed a deduction under 26 USC § 151 for the taxable year, which typically includes: (1) the taxpayer, (2) his or her spouse, and (3) any claimed dependents (26 USC § 36B(d)(1)).

### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer’s coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

### Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Medicaid - Eligibility

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In the case of a married couple living together, each spouse will be included in the household of the other spouse, regardless of whether they expect to file a joint tax return (42 CFR § 435.603(f)(4)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you were eligible for APTC of up to \$250.00 per month as of April 26, 2017.

The application that was submitted on April 25, 2017 listed an annual household income of \$34,956.00, and the eligibility determination relied upon that information.

When calculating family size for APTC, a household size consists of the taxpayer, his or her spouse, and any claimed dependents. You attested in that application that you expected to file your 2017 tax return, with the tax status of married filing jointly, and do not expect to claim any dependents on that tax return. Therefore, you were in a two-person household.

You reside in New York County, where the second lowest cost silver plan for an individual through NYSOH costs \$456.46 per month.

An annual income of \$34,956.00 is 218.20% of the 2016 FPL for a two-person household. At 218.20% of the FPL, the expected contribution to the cost of the health insurance premium in 2017 is 7.08% of income, or \$206.24 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$206.24 per month), which equals \$250.22 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$250.00 per month in APTC.

The second issue under review is whether you were properly found eligible for CSR.

Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a two-person household with an income

of \$34,956.00 is 218.20% of the FPL, NYSOH correctly found you to be eligible for CSR.

The third issue under review is whether NYSOH properly determined you ineligible for Medicaid as of April 26, 2017.

When a married couple is living together, each spouse will be included in the household of the other spouse, regardless of whether they expect to file a joint tax return.

The record reflects that you currently live with your spouse. Therefore, you are in a two-person household for the purpose of calculating your eligibility for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,868.00 per month for a two-person household.

The record as of April 26, 2017, reflects that your household was being issued \$2,913.00 per month ( $\$34,956.00 / 12$  months). Therefore, your monthly income exceeded the maximum allowable monthly income amount of \$1,868.00, and you did not qualify for Medicaid.

The April 26, 2017, eligibility determination notice properly determined you eligible for up to \$250.00 of APTC and CSR, and ineligible for Medicaid. Therefore, it is correct and AFFIRMED.

## **Decision**

The April 26, 2017 eligibility determination notice is AFFIRMED.

## **If You Disagree with this Decision (Appeal Rights)**

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
