## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On April 28, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible to purchase a qualified health plan (QHP) at full cost, effective June 1, 2017. However, the notice also stated that you and your spouse were not eligible to select a health plan outside of the open enrollment period for 2017. You appealed that determination insofar as you were seeking to enroll you and your spouse in a QHP, with such coverage beginning May 1, 2017.

On July 18, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you and your spouse had subsequently been permitted to reenroll in a QHP with such coverage beginning on May 1, 2017.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
