Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective June 1, 2017?

Procedural History

On February 18, 2017, NY State of Health (NYSOH) issued a notice stating that your February 17, 2017 application for health insurance had been reviewed, but the income information did not match what NYSOH received from state and federal data sources. You were instructed to submit proof of household income by March 4, 2017.

On March 30, 2017, NYSOH issued a notice stating that the documentation you submitted did not confirm the information in your application. You were again instructed to send in more proof to verify your household income by April 18, 2017.

On April 21, 2017, NYSOH issued an eligibility determination notice, based on the updated April 20, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective June 1, 2017.

On April 28, 2017, NYSOH issued a plan enrollment notice, based on your plan selection on April 27, 2017, confirming your enrollment in an Essential Plan 1, with a \$20.00 monthly premium and start date of June 1, 2017.

Also on April 28, 2017, NYSOH issued a notice confirming that on April 27, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin March 1, 2017.

On August 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYOSH account and your testimony, you submitted your initial application to NYSOH for financial assistance on February 17, 2017.
- 2) According to your NYSOH account, on March 21, 2017, a one-page statement of earnings and deductions for pay period of 01/30/2017 through 02/05/2017 with pay date of 02/09/2017 for gross pay of \$275.00 was uploaded to your account.
- 3) According to your NYSOH account, on April 19, 2017, a five-page document was uploaded to your NYSOH account. This included four statements of earnings and deductions from March 2017.
- 4) According to your NYSOH account, these documents were verified on April 19, 2017, your application was updated on April 20, 2017 and you were determined eligible for the Essential Plan effective June 1, 2017.
- 5) According to your NYSOH account and your testimony, on April 27, 2017 you enrolled in Essential Plan 1 with a plan start date of June 1, 2017.
- 6) You testified that you wanted your enrollment in an Essential Plan to begin on March 1, 2017 because you do not want to incur a tax penalty for not having health insurance for more than two months in 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates

for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective June 1, 2017.

You testified, and the record indicates, that you submitted your initial NYSOH application for health insurance on February 17, 2017. NYSOH issued a notice that the income information in your application did not match what NYSOH had received from state and federal sources. You were directed to provide proof of your income by March 4, 2017.

On March 21, 2017, you submitted one earnings and deductions statement dated February 9, 2017. On March 30, 2017 NYSOH issued a notice that the document you submitted did not confirm the information in your application and you were directed to submit additional proof of income by April 18, 2017. On April 19, 2017, you submitted four earnings and deductions statements for the month of March 2017. On April 19, 2017 those documents were verified and your application was updated. On April 21, 2017, NYSOH issued an eligibility determination stating that you were eligible for the Essential Plan as of June 1, 2017. You enrolled into an Essential Plan on April 27, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On April 27, 2017, you selected an Essential Plan, which is after the 15th of the month, so your enrollment properly took effect on the first day of the second month following April 2017; that is, on June 1, 2017.

Therefore, the April 28, 2017, enrollment confirmation notice stating that your enrollment in the Essential Plan was effective June 1, 2017, is correct and must be AFFIRMED.

Sometimes after an appeal decision, an appellant can claim an exemption from the requirement to have health insurance. You might qualify for a health coverage exemption in 2017 if you didn't have health coverage while you were waiting for an appeal decision about coverage eligibility or savings **and** your appeal was eventually successful.

You must claim this exemption through the United States Department of Health and Human Services (HHS). Currently, NYSOH does not accept hardship exemption applications.

Important: If you do not get a response from HHS to your exemption application in time to file your tax return, write the word "pending" in column "c" and file your return. If HHS does not approve your exemption, you will need to file an amended return later.

Decision

The April 28, 2017 enrollment confirmation notice is AFFIRMED.

This Decision does not affect any subsequent eligibility determinations made by NYSOH.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
