Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in an Essential Plan was effective June 1, 2017?

Procedural History

On January 31, 2017, your NYSOH account was updated.

On February 1, 2017, NYSOH issued a notice informing you that additional information was needed in the form of income documentation to confirm your eligibility.

On February 9, 2017, income documentation was uploaded to your NYSOH account and verified by NYSOH on February 21, 2017.

On February 22, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan for a limited time with a \$20.00 monthly premium, effective April 1, 2017. The notice also instructed you as to how to pick a plan.

On May 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin April 1, 2017.

On May 2, 2017, based on your May 1, 2017 plan selection, NYSOH issued a plan enrollment notice confirming your enrollment in an Essential Plan 1 Plus Vision and Dental with a \$47.49 monthly premium and an enrollment start date of June 1, 2017.

On August 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an updated application to NYSOH for financial assistance on January 31, 2017.
- 2) According to your NYSOH, you were determined eligible to enroll in the Essential Plan for a limited time, effective April 1, 2017.
- 3) The February 22, 2017 notice instructed you on how to pick a health plan.
- 4) You testified that after receiving the February 22, 2017 eligibility determination notice, you called and spoke with a NYSOH customer service representative who said she would pick a plan for you. However, you were unsure when you had this conversation.
- 5) According to your NYSOH account, there is no record of you contacting NYSOH from February 22, 2017 until May 1, 2017.
- 6) According to your NYSOH account and your testimony, you selected and enrolled in an Essential Plan on May 1, 2017.
- 7) You testified that you want your enrollment in an Essential Plan to begin on April 1, 2017 to cover medical bills you incurred in April 2017 and May 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in the Essential Plan was effective June 1, 2017 and not April 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on January 31, 2017. As a result, you were found eligible for the Essential Plan as of February 22, 2017, as stated in the eligibility determination notice of that date. You testified that after receiving the February 22, 2017 eligibility determination notice, you called and spoke with a NYSOH customer service representative who said she would pick a plan for you. However, you were unsure when you had this conversation. According to your NYSOH account, there is no record of you contacting NYSOH from February 22, 2017 until May 1, 2017. You testified and the record indicates that you selected an Essential Plan on May 1, 2017 and were enrolled that same day with an enrollment start date of June 1, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On May 1, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the first month following May 2017; that is, on June 1, 2017.

Therefore, the May 2, 2017 plan enrollment notice stating that your enrollment in the Essential Plan was effective June 1, 2017, is correct and must be AFFIRMED.

Decision

The May 2, 2017 plan enrollment notice is AFFIRMED.

Effective Date of this Decision: September 13, 2017

How this Decision Affects Your Eligibility

This decision does not change your eligibility for or enrollment in the Essential Plan.

The effective enrollment start date of your Essential Health Plan is June 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

This decision does not change your eligibility for or enrollment in the Essential Plan.

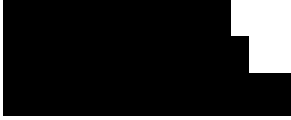
The effective enrollment start date of your Essential Health Plan is June 1, 2017.
