## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On April 26, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective June 1, 2017. You appealed this determination.

On July 10, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 14, 2017, at 3:00 p.m.

On August 14, 2017, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH using the services of a Spanish interpreter at 3:00 p.m. at the phone number listed in your NYSOH account as your primary phone number, but the phone number you provided, [REDACTED] was not in service. The Hearing Officer called this primary phone number again at 3:19 p.m. and 3:28 p.m. and received the same automated message that the number was not in service. The Hearing Officer also had the Spanish interpreter call you at the secondary phone number listed as a cell number in your account [REDACTED] and could not leave a message. Please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
