Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your oldest child was not eligible for Medicaid?

Procedural History

On May 1, 2017, you submitted an application for financial assistance. That day, a preliminary eligibility determination was prepared stating that your oldest child was not eligible to for financial assistance, but was eligible to purchase a qualified health plan at full cost, effective June 1, 2017.

Also on May 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the determination, insofar as your oldest child was not determined eligible for Medicaid.

On May 2, 2017, NYSOH issued a notice of eligibility determination, based on the May 1, 2017 application, stating that your oldest child was eligible to purchase a qualified health plan at full cost, effective June 1, 2017. That notice also stated that you were not eligible for Medicaid because your income was over the allowable income limits for those programs.

On August 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim two dependents on that tax return.
- 2) You are seeking Medicaid for your oldest child as secondary coverage to his employer-sponsored coverage through your spouse's employer.
- 4) The application that was submitted on May 1, 2017 listed annual household income of \$109,199.99, consisting of \$64,999.99 you earn from your employment and \$44,200.00 your spouse earns from his employment.
- 5) You testified that your spouse's income is correct, but that you left your job at the end of May 2017, and you now expect to earn between \$52,000.00 and \$55,000.00.
- 6) You testified that your monthly income for May 2017 was \$5,000.00, and that your spouse earned around \$3,200.00.
- 7) Your application states that you will not be taking any deductions on your 2017 tax return. You testified that you will be taking a student loan interest deduction.
- 8) Your application states that you live in

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Children

A child who is at least one year of age but younger than nineteen is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 154% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.118(c); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In the case of an individual who expects to file a tax return and does not expect to be claimed by another taxpayer, the household consists of the taxpayer and all persons whom such individual expects to claim as a tax dependent (42 CFR § 435.603(f)(1).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$24,600.00 for a four-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your oldest child was not eligible for Medicaid.

The application that was submitted on May 1, 2017 listed an annual household income of \$109,199.99 and the eligibility determination relied upon that information.

You are in a four-person household. You expect to file your 2017 income taxes as married filing jointly and will claim two dependents on that tax return.

Medicaid can be provided through NYSOH to children who are at least one year of age but younger than nineteen who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 154% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$24,600.00 for a four-person household. Since \$109,199.00 is 443.9% of the 2017 FPL, NYSOH properly found your oldest child to be not eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You credibly testified that in May 2017, you earned \$5,000.00 and your spouse earned about \$3,200.00, yielding a monthly gross income of \$8,200.00.

To be eligible for Medicaid, your oldest child would need to meet the non-financial criteria and have an income no greater than 154% of the FPL, which is

\$3,157.00 per month. Since you testified that your household earned \$8,200.00 in May 2017, your oldest child does not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the May 2, 2017 eligibility determination properly stated that, based on the information you provided, your oldest child was not eligible for Medicaid, it is correct and is AFFIRMED.

Decision

The May 2, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your oldest child is not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
