## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Was your appeal of NY State of Health's (NYSOH) February 19, 2017 enrollment confirmation notice timely?

Did NYSOH properly determine that your spouse's enrollment in her Medicaid Managed Care plan was effective March 1, 2017?

## Procedural History

On February 14, 2017, NYSOH issued a notice of eligibility determination, based on your February 13, 2017 application, stating that your spouse was eligible for Medicaid, effective February 1, 2017.

On February 19, 2017, NYSOH issued a notice of enrollment in the plan you selected on February 13, 2017, stating that your spouse was enrolled in a Medicaid Managed Care plan, and that your spouse's coverage would start on March 1, 2017.

On May 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your spouse's enrollment in her Medicaid Managed Care plan, insofar as it did not begin February 1, 2017.

On August 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held

open to allow the Hearing Officer time to review telephone recordings. One recording was reviewed.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on February 13, 2017.
- 2) You testified, and the record reflects, that you selected your spouse's Medicaid Managed Care Plan on February 13, 2017, and that her enrollment was effective on March 1, 2017.
- 3) You testified that you want your spouse's Medicaid Managed Care plan to begin on February 1, 2017 because she has outstanding bills from medical services rendered in February 2017.
- 4) Your spouse placed a phone call to NYSOH on February 23, 2017. During that call, she requested information regarding her health insurance cards. The NYSOH representative advised her that a card was mailed on February 18, 2017, and that she was fully covered if she needed to see her doctor [REDACTED].

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Valid Appeal Requests

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by the Exchange to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Individual applicants and enrollees must request a hearing within sixty (60) days of the date of their notice of eligibility determination by NYSOH (45 CFR §155.520(b)(2); 18 NYCRR 358-3.5(b)(1)).

However, where an appeal request is untimely, the appeal request may be considered valid if the applicant or enrollee sufficiently demonstrates within a reasonable timeframe as determined by NYSOH that failure to timely submit the appeal was due to exceptional circumstances and should not preclude the appeal (45 CFR §155.520(d)(2)(i)(D)).

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The first issue under review is whether your appeal of NYSOH's February 19, 2017 enrollment confirmation notice was timely.

The record reflects that you first contacted NYSOH regarding your spouse's enrollment start date on May 1, 2017. At that time, a complaint was opened, and an appeal filed.

Individual applicants and enrollees must request a hearing within sixty (60) days of the date of the notice of eligibility determination by NYSOH.

For an appeal to have been valid on the issue of your enrollment start date as stated in the February 19, 2017 enrollment confirmation notice, an appeal should have been filed by April 20, 2017.

Although your appeal was untimely on its face, the record reflects that your spouse called NYSOH on February 23, 2017 regarding her health insurance cards, and inquired regarding the status of her coverage. The NYSOH representative advised her that she was fully covered at the time of the call.

As your spouse originally contacted NYSOH within sixty (60) days of the February 23, 2017 and spoke with a representative about the status of her

coverage, your failure to timely submit the appeal was due to exceptional circumstances and should not preclude the appeal.

The second issue is whether NYSOH properly determined that your spouse's enrollment in her Medicaid Managed Care plan was effective March 1, 2017.

You testified that you contacted NYSOH on February 13, 2017 and enrolled your spouse into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On February 13, 2017, your spouse selected a Medicaid Managed Care plan, so it properly took effect on the first day of the following month; that is, on March 1, 2017.

Therefore, the February 19, 2017 enrollment confirmation notice stating that your spouse's enrollment in her Medicaid Managed Care plan would be effective March 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The February 19, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your spouse's eligibility.

The effective date of your spouse's Medicaid Managed Care plan is March 1, 2017.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
