Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children's eligibility for and enrollment in their Child Health Plus plan was effective May 1, 2017?

Procedural History

On March 10, 2016, NYSOH issued a notice of eligibility determination, based on your March 9, 2016 application, stating that your children were eligible for Child Health Plus, effective April 1, 2016. Your children were subsequently enrolled in a Child Health Plus plan.

On February 3, 2017, NYSOH issued a notice stating that it was time to renew your children's health insurance for 2017. That notice stated that, based on information from federal and state sources, NYSOH could not determine whether your children would qualify for financial help paying for their health coverage, and that you needed to update your account by March 15, 2017 or your children might lose the financial assistance they were currently receiving.

No updates were made to your account by March 15, 2017.

On March 16, 2017, NYSOH redetermined your eligibility.

On March 17, 2017, NYSOH issued an eligibility determination notice stating that your children were not eligible for Medicaid, Child Health Plus, or to receive tax

credits or cost-sharing reductions to help pay for the cost of insurance. Your children also could not enroll in a qualified health plan at full cost. This was because you had not responded to the renewal notice and had not completed the renewal within the required time frame. Your children's eligibility ended effective March 31, 2017.

On March 27, 2017, NYSOH received your children's updated application for health insurance.

On March 28, 2017, NYSOH issued a notice of eligibility determination, based on your March 27, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$45.00 monthly premium each, effective May 1, 2017.

Also on March 28, 2017, NYSOH issued a notice of enrollment, based on your plan selection on March 27, 2017, stating that your children were enrolled in a Child Health Plus plan and that coverage would start on May 1, 2017.

On May 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin April 1, 2017.

On August 9, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you receive your notices from NYSOH by electronic mail.
- 2) You testified that you did receive an electronic alert regarding a notice in your NYSOH account telling you that you needed to update your application to renew your children's coverage.
- 3) You testified that you did not update your application after receiving the renewal notice.
- 4) You testified that you received a telephone call from your insurer at the end of March 2017 advising you that you had not re-enrolled your children into coverage.
- 5) The record reflects that on March 27, 2017, NYSOH received your children's updated application for health insurance.

- 6) You testified that you have medical bills for your children that were incurred during April 2017.
- 7) You testified that you are seeking that your children be enrolled in their Child Health Plus plan as of April 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Annual Eligibility Redetermination

Generally, when NYSOH conducts annual eligibility redeterminations for qualified individuals who are seeking financial assistance through insurance affordability programs for the upcoming year, NYSOH is required to request that the qualified individual provide updated income and family size information for use in an eligibility redetermination for the upcoming year (see 45 Code of Federal Regulations (CFR) § 155.335(a), (b)).

NYSOH must send an annual renewal notice that contains the individual's projected eligibility for the upcoming year (45 CFR § 155.335(c)(3)). If a qualified individual does not respond to the notice after a 30-day period, NYSOH must redetermine that individual's eligibility using the information and projected eligibility provided in the annual renewal notice (45 CFR § 155.335(g), (h)). NYSOH must ensure this redetermination is effective on the first day of the coverage year or in accordance with the rules specified in 45 CFR § 155.330(f) regarding effective dates, whichever is later (45 CFR § 155.335(i)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid, or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs

as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant’s account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual’s NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective May 1, 2017.

Your children were originally found eligible for Child Health Plus effective April 1, 2016.

Generally, NYSOH must redetermine a qualified child's eligibility for Child Health Plus once every 12 months without requiring information from the individual, if it is able to do so based on reliable information contained in the individual's account or other more current information available to the agency. NYSOH's February 3, 2017 renewal notice stated that there was not enough information to determine whether your children were eligible to continue to receive financial assistance for health insurance, and that you needed to supply additional information by March 15, 2017, or any such financial assistance might end.

Because there was no timely response to this notice, your children were terminated from their Child Health Plus plan, effective March 31, 2017.

You testified and the record reflects that you elected to receive alerts regarding notices from NYSOH electronically. You credibly testified that you did receive an electronic alert regarding the renewal notice, which directed you to update the information in your NYSOH account on behalf of your children. You testified that you did not update your application after receiving the renewal notice.

Therefore, it is concluded that NYSOH did give you the proper notice that you needed to update your account on your children's behalf.

You first renewed your child's eligibility for financial assistance through NYSOH for the new coverage year on March 27, 2017, and therefore NYSOH correctly determined that your children's coverage in their Child health Plus plan was effective May 1, 2017.

Therefore, the March 28, 2017 eligibility determination and enrollment confirmation notices are AFFIRMED.

Decision

The March 28, 2017 eligibility determination and enrollment confirmation notices are AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility for and enrollment in their Child Health Plus plan.

NYSOH correctly determined that the start date for your children's Child Health Plus plan was May 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
