On April 21, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective June 1, 2017. You appealed that determination.

On July 6, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 2, 2017, at 9:00 am.

A Hearing Officer called you at 9:00 am on August 2, 2017. Although you answered the call, you stated that you were not sure if you still wanted to proceed with the appeal, and requested an adjournment.

The Hearing Officer granted an adjournment to August 7, 2017 at 9:00 am.

Also on August 2, 2017, you spoke with NYSOH's Account Review Unit and requested to withdraw your appeal.

As you have withdrawn your appeal, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
