NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On March 21, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in a qualified health plan at full cost, effective May 1, 2017. Also on March 21, 2017, NYSOH issued a notice of disenrollment, stating that your coverage with your Essential Plan would end on April 30, 2017. On May 3, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan, effective June 1, 2017. Also on May 3, 2017, NYSOH issued an enrollment notice stating that you were reenrolled into your Essential Plan, effective June 1, 2017. You appealed these determinations.

On August 11, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because NYSOH had backdated your enrollment in your Essential Plan to May 1, 2017.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
