## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were eligible to receive up to \$68.00 per month in advance payments of the premium tax credit effective April 1, 2017?

## Procedural History

On December 22, 2016, NY State of Health (NYSOH) received your application for financial assistance with your health insurance.

On December 23, 2016, NYSOH issued a notice of eligibility determination stating that you were conditionally eligible to receive up to \$168.00 per month in advance payments of the premium tax credit (APTC), effective February, 1 2017. The notice further directed you to provide documentation confirming your income before March 22, 2017. The household income listed in your application was \$31,200.00.

On December 23, 2016, NYSOH issued a notice confirming your enrollment in silver level qualified health plan with APTC, effective February 1, 2017.

No income documentation was received by the deadline of March 22, 2017.

On March 27, 2017, NYSOH redetermined your eligibility for financial assistance.

On March 28, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$68.00 per month in APTC, effective May 1, 2017. The notice stated you qualify for APTC because federal and state data sources show your household income is between \$16,395.00 and \$47,520.00. The notice stated your APTC was adjusted because you did not provide satisfactory proof of your household income within the required time frame, NYSOH used federal and state data sources to determine your amount of financial assistance.

On March 28, 2017, NYSOH issued a notice confirming your enrollment in a silver level qualified health plan with APTC, effective April 1, 2017.

On May 2, 2017, you spoke to NYSOH's Account Review Unit and appealed the level of APTC you were determined eligible for effective April 1, 2017.

On August 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to 15 days for you to provide proof of your household income.

On August 16, 2017 NYSOH Appeals Unit received your supporting documentation and has been incorporated into the record as Appellant's Exhibit 1. The record was closed that day.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified, and your account indicates, that you receive all of your notices from NYSOH by regular mail.
- 2) You testified that you did not receive any notices stating that your eligibility was only conditional and that you needed to provide documentation of your household's income by March 22, 2017.
- 3) No notices that were sent to the address listed on your NYSOH account have been returned as undeliverable.
- 4) You testified that you did not know that you needed to submit documentation of your income until you had an increased premium responsibility due for the month of April 2017.
- 5) No income documentation was received by NYSOH before the requested deadline of March 22, 2017.

- 6) Your NYSOH account indicates that on March 27, 2017 your application was run and you were found eligible for APTC up to \$68.00 per month. This was applied to your premium bill starting April 1, 2017.
- 7) You submitted income documentation to NYSOH Appeals Unit and sent it to NYSOH via fax on August 16, 2017.
- 8) You testified that you are seeking reinstatement of your APTC at the level of \$150.00 as of April 1, 2017.
- 9) You reside in [REDACTED], NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Verification of Eligibility for Advance Payments of the Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

An applicant is required to attest to their household's projected annual income for purposes of determining their eligibility for APTC (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility

based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any changes in eligibility to APTC effective as of the first day of the month following the date of the notice (45 CFR § 155.310(f), 45 CFR § 155.330(e), (f)(1)(i)).

### Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were eligible to receive up to \$68.00 per month in advance payments of the premium tax credit effective April 1, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to their household's projected annual income. For individuals seeking APTC, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on December 23, 2016, you were advised that your eligibility for APTC was only conditional, and that you needed to confirm your household's income before March 22, 2017.

You testified that you did not receive any notice from NYSOH telling you that you needed to provide income documentation to confirm your eligibility. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, NYSOH properly notified you of an inconsistency in your account and that documentation was needed to confirm the income you listed in the account.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation.

Since NYSOH did not receive your income documentation by March 22, 2017 to support the income listed in your application, NYSOH is required to determine your eligibility based on federal and state data sources. According to data sources, your income was between \$16,395.00 and \$47,520.00.

APTC is available to anyone with a household income between 138% and 400% of the Federal Poverty Level. Since the data sources showed that your household income was within the applicable level, NYSOH was proper in determining you eligible for \$68.00 based on the income level the data sources provided as of March 27, 2017.

Any changes in APTC are to be made effective the date following the eligibility redetermination notice.

Accordingly, your change in APTC level of \$68.00 per month should have started the first day of the month following the March 28, 2017, notice, or April 1, 2017.

Therefore, the March 28, 2017, eligibility determination notice is MODIFIED to state that you were eligible to receive up to \$68.00 per month in APTC, effective April 1, 2017, because NYSOH did not receive the income documentation needed to verify the income listed in your application.

## **Decision**

The March 28, 2017, eligibility determination notice is MODIFIED to state that you were eligible to receive up to \$68.00 per month in APTC, effective April 1, 2017.

## **How this Decision Affects Your Eligibility**

You were eligible for APTC up to \$68.00 per month starting April 1, 2017.

This decision has no effect on any subsequent eligibility determinations made by NYSOH.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
