Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your MVP Medicaid Managed Care plan was effective June 1, 2017?

Procedural History

On April 12, 2017, NYSOH issued a notice of eligibility determination, based on your April 11, 2017 application, stating that you were eligible for Medicaid, effective April 1, 2017.

Also on April 12, 2017 NYSOH issued a notice of enrollment in the plan you selected on April 11, 2017, stating that you were enrolled in a Fidelis Medicaid Managed Care plan, and that your coverage would start on May 1, 2017.

On April 21, 2017, you contacted NYSOH and requested to change your Medicaid Managed Care plan.

On April 22, 2017, NYSOH issued a notice of enrollment in a MVP plan you selected on April 21, 2017, stating that you were enrolled in a MVP Medicaid Managed Care plan, and that your coverage would start on June 1, 2017.

On May 2, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your MVP Medicaid Managed Care plan, insofar as it did not begin April 1, 2017.

On August 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on April 11, 2017.
- 2) The record reflects, that you selected a Fidelis Medicaid Managed Care Plan on April 11, 2017, and that your enrollment in that plan was effective on May 1, 2017.
- 3) You testified that you selected an MVP Medicaid Managed Care plan at the end of April 2017. The record reflects that you selected a MVP Medicaid Managed Care plan on April 22, 2017, and that your enrollment in that plan was effective on June 1, 2017.
- 4) You testified that you want your MVP Medicaid Managed Care plan to begin on April 1, 2017 because you have outstanding bills that are not covered by fee-for-service Medicaid or the Fidelis Medicaid Managed Care plan. Additionally, your providers do not accept Fidelis.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the MVP Medicaid Managed Care plan was effective June 1, 2017.

You testified that you first enrolled in a Fidelis Medicaid Managed Care plan, but that you learned that your providers do not accept Fidelis. You testified that you contacted NYSOH in the end of April 2017 and enrolled into a MVP Medicaid Managed Care plan in order to continue to treat with your doctors. The record reflects that you selected the MVP Medicaid Managed Care plan on April 21, 2017.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On April 21, 2017, you selected a MVP Medicaid Managed Care plan, so it properly took effect on the first day of the second month following after April 2017; that is, on June 1, 2017.

Therefore, the April 22, 2017 enrollment confirmation notice stating that your enrollment in your MVP Medicaid Managed Care plan would be effective June 1, 2017, was correct and must be AFFIRMED.

Decision

The April 22, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your MVP Medicaid Managed Care plan is June 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
