## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were no longer eligible for Medicaid and properly terminate your Medicaid Managed Care (MMC) coverage effective April 30, 2017?

## Procedural History

On June 30, 2016, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective as of July 1, 2016.

On June 30, 2016, NYSOH issued a plan enrollment notice confirming that you were enrolled in a MMC plan with an enrollment start date of July 1, 2016.

On February 17, 2017, your NYSOH account was updated.

On February 18, 2017, NYSOH issued an enrollment notice confirming that you were enrolled in a MMC plan with an enrollment start date of July 1, 2016.

On March 6, 2017, the February 18, 2017 enrollment notice was returned to NYSOH and stamped, "RETURN MAIL" (see Document [REDACTED] uploaded 4/14/2017).

On April 14, 2017, your NYSOH account was systematically updated.

On April 15, 2017, NYSOH issued an eligibility determination notice stating, in relevant part, that you were no longer qualified for Medicaid effective April 15, 2017. The notice stated that information about your eligibility and coverage was sent by U.S. mail to the mailing address provided in your account. However, the information was returned to NYSOH as undeliverable.

Also on April 15, 2017, NYSOH issued a disenrollment notice stating that your MMC coverage would end on April 30, 2017.

On April 27, 2017, your NYSOH account was updated.

On April 28, 2017, NYSOH issued three notices:

- (1) An eligibility determination notice stating that you were eligible for Medicaid, effective as of May 1, 2017;
- (2) A plan enrollment notice confirming that as of April 27, 2017, you were enrolled in a MMC plan with an enrollment start date of June 1, 2017;
- (3) A notice stating that you have changed your mailing address to: [REDACTED]

On May 2, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as your MMC plan was terminated as of April 30, 2017.

On July 25, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- 1) According to your NYSOH account and testimony, you were enrolled in a MMC plan through Empire BlueCross BlueShield HealthPlus (Empire), with an enrollment start date of July 1, 2016.
- 2) On February 18, 2017, NYSOH issued an enrollment notice confirming your MMC plan enrollment to the mailing address [REDACTED] Document [REDACTED]).
- 3) The February 18, 2017, enrollment notice was returned to NYSOH as undeliverable on March 6, 2017 (Document [REDACTED]).

- 4) According to your NYSOH account, on April 27, 2017, your mailing address was updated to [REDACTED]
- 5) You testified that [REDACTED] is your [REDACTED] mailing address and you listed her address for simplicity.
- 6) You testified that you reside at [REDACTED] and have resided there for approximately three years.
- 7) You testified you first learned about being disenrolled from your MMC plan as of April 30, 2017, when you were contacted by your health insurance company.
- 8) According to your NYSOH account, you re-enrolled in the same MMC plan on April 27, 2017, with an enrollment start date of June 1, 2017.
- 9) You testified you are seeking to have any medical expenses that were incurred in the month of May 2017 to be covered by the MMC plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR §§ 435.119(b), 435.911(b)(1), 435.603(d)(4); NY Social Services Law § 366(1)(b)).

### Medicaid - Continuous Coverage

Most adults determined eligible for Medicaid are guaranteed 12 months of Medicaid coverage, unless the adult loses Medicaid eligibility because of citizenship status, lack of state residence, or failure to provide a valid social security number, before the end of a twelve-month period. This twelve-month period is referred to as "continuous coverage," and is set based on the start date of the original Medicaid eligibility determination or the date of a subsequent Medicaid eligibility determination based on modified adjusted gross income (see 42 CFR § 435.916(a); N.Y. Soc. Serv. Law § 366(4)(c)).

## Medicaid - State Residency

NYSOH must provide Medicaid to eligible residents of the state of New York, including residents who are absent from the state (42 CFR § 435.403(a)).

For an individual who is age 21 or older, not living in an institution, and able to indicate intent, state residency is the state where the individual is living and, either: (1) where they intend to reside, including without a fixed address, or (2) has entered the state with a job commitment or is seeking employment (42 CFR § 435.403(h)(1)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were ineligible for Medicaid and properly terminated your MMC plan effective April 30, 2017.

You were determined eligible for Medicaid effective July 1, 2016 and enrolled in a MMC plan, through Empire, with an enrollment start date of July 1, 2016. On February 18, 2017, NYSOH issued a notice confirming your MMC plan enrollment to the mailing address you had provided. However, that notice was returned to NYSOH as undeliverable on March 6, 2017. Since the notice was returned to NYSOH, your eligibility for health insurance was redetermined.

Generally, once individuals are determined eligible for Medicaid, they are guaranteed 12 months of Medicaid coverage, even if they lose Medicaid eligibility because of any changes in their household income. This twelve-month period is based on the start date of the original Medicaid eligibility determination. Exceptions to this rule include changes in citizenship status, lack of state residence, or failure to provide a valid social security number.

You testified that you reside at [REDACTED] and have resided there for approximately three years. You also testified that [REDACTED] is your [REDACTED] mailing address and had reported that to be your mailing address for simplicity.

There is sufficient evidence in the record to conclude that you have continuously retained New York State residency and no other issue regarding your eligibility existed.

When your MMC coverage was discontinued on April 30, 2017, the twelve-month period of Medicaid eligibility that began on July 1, 2016, had not expired. Furthermore, the record does not contain any evidence that your eligibility should have been discontinued before the end of your twelve-month eligibility period.

Therefore, the April 15, 2017, eligibility determination and disenrollment notices are RESCINDED.

Your case is RETURNED to NYSOH to reinstate your MMC coverage effective May 1, 2017, and to notify you accordingly.

The April 15, 2017, eligibility determination is RESCINDED.

The April 15, 2017, disenrollment notice is RESCINDED.

Your case is RETURNED to NYSOH to reinstate your MMC coverage effective May 1, 2017, and to notify you accordingly.

## **How this Decision Affects Your Eligibility**

NYSOH incorrectly terminated your Medicaid coverage effective April 30, 2017.

Your case has been returned to NYSOH to effectuate your MMC coverage for the month of May 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
