Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's eligibility for and enrollment in his Child Health Plus plan was effective June 1, 2017?

Procedural History

On March 30, 2017, your child was added to your NYSOH account. That day, a non-financial assistance application was submitted on his behalf.

On March 31, 2017, NYSOH issued an eligibility determination notice stating that your child did not qualify to select a health plan outside of the open enrollment period. If he qualified for a special enrollment period, he would be eligible to purchase a qualified health plan at full cost, effective May 1, 2017.

On April 28, 2017, two non-financial applications for health insurance were submitted on your child's behalf. Your account was updated a third time and an application for financial assistance with health insurance was submitted on your child's behalf.

On April 29, 2017, NYSOH issued an eligibility determination notice, based on the third application submitted on April 28, 2017, stating that your child was eligible to enroll in Child Health Plus with a \$30.00 monthly premium, effective June 1, 2017.

Also on April 29, 2017, NYSOH issued an enrollment confirmation notice, based on your plan selection on April 28, 2017, stating that your child was enrolled in a Child Health Plus plan, and that this enrollment would start June 1, 2017.

On May 3, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin May 1, 2017.

On August 9, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the effective date of your child's enrollment in his Child Health Plus plan.
- 2) Your child was added to your NYSOH account on March 30, 2017. The application submitted that day was for non-financial assistance.
- 3) Your child was added to your qualified health plan for the month of May 2017.
- 4) You submitted an updated application to NYSOH in which you requested financial assistance with your child's health insurance on April 28, 2017.
- 5) You testified, and the record reflects, that you enrolled your child into a Child Health Plus plan on April 28, 2017.
- 6) Your child's March 30, 2017 and April 28, 2017 applications were submitted by a certified application counselor.
- 7) You testified that you need your child's Child Health Plus plan to begin on May 1, 2017 because he had [REDACTED] in May that was not covered by the qualified health plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your child’s eligibility for and enrollment in his Child Health Plus plan was effective June 1, 2017.

Your child was added to your NYSOH account on March 30, 2017 by a certified application counselor. The application submitted that day was for non-financial assistance.

On April 28, 2017, your certified application counselor submitted an updated application to NYSOH in which you requested financial assistance with your child’s health insurance.

On April 29, 2017, NYSOH issued an eligibility determination and an enrollment confirmation notice, stating that your child was eligible for and enrolled in a Child Health Plus plan as of June 1, 2017.

You testified that you need your child’s Child Health Plus plan to begin on May 1, 2017 because he had [REDACTED] in May that was not covered by the qualified health plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since your application was updated to indicate that your child was seeking financial assistance with his health insurance on April 28, 2017 and he was enrolled in a plan that same day, your child's eligibility and enrollment should begin on the first day of the second following month after April 2017; that is June 1, 2017.

Therefore, the April 29, 2017 eligibility determination and enrollment confirmation notices stating that your child's eligibility for and enrollment in his Child Health Plus plan was effective June 1, 2017, is correct and must be AFFIRMED.

Decision

The April 29, 2017 eligibility determination notice is AFFIRMED.

The April 29, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is June 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
