Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were no longer eligible for financial assistance, effective April 1, 2017?

Procedural History

On December 9, 2016, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$323.00 per month in advance payments of premium tax credit (APTC) for a limited time, effective January 1, 2017. The notice further directed you to provide documentation confirming your household income before March 8, 2017.

Also on December 9, 2016, NYSOH issued a plan enrollment notice confirming that as of December 8, 2016, you were enrolled in a qualified health plan (QHP), with an enrollment start date of January 1, 2017. The notice further directed you to provide documentation confirming your household income before March 8, 2017.

As of March 8, 2017, no income documentation was provided to NYSOH.

On March 15, 2017, your NYSOH account was systemically updated.

On March 16, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a QHP at full cost, effective as of April 1,

2017. The notice stated this was because NYSOH did not receive the income documentation needed to verify the income listed in your application.

On March 16, 2017, NYSOH issued a plan enrollment notice confirming that you were enrolled in a QHP with an enrollment start date of January 1, 2017.

On May 5, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as your financial assistance through NYSOH was discontinued.

On August 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the proceeding.

Findings of Fact

A review of the record supports the following findings of fact:

1. According to your NYSOH account, you receive all notices from NYSOH by regular mail.
2. You testified that you never received any notice from NYSOH and were not aware that income documentation was needed to confirm your eligibility.
3. According to your NYSOH account, none of the notices that were issued were returned as undeliverable.
4. According to your NYSOH account, [REDACTED] was listed as your mailing address from November 11, 2013 through May 5, 2017.
5. You testified you may not have received the notices because "[REDACTED]" was not added to your account.
6. You testified that you discovered your financial assistance had ended when your credit card statement indicated that your health insurance premium had increased.
7. You testified that you want the tax credit to be applied to your April 2017 health insurance premium.
8. Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for Advance Payments of the Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

An applicant is required to attest to their household's projected annual income for purposes of determining their eligibility for APTC (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any changes in eligibility to APTC effective as of the first day of the month following the date of the notice (45 § 155.310(f), 45 CFR § 155.330(e), (f)(1)(i)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your financial assistance ended effective April 1, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to their household's projected annual income. For individuals seeking APTC, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

The notices issued on December 9, 2016, advised you that your eligibility for financial assistance was only conditional, and that you needed to confirm your household's income before March 8, 2017. The record reflects that NYSOH did not receive the requested income documentation before March 8, 2017.

You testified that you did not receive any notice from NYSOH telling you that you needed to provide income documentation to confirm your eligibility. Your NYSOH account confirms, that you elected to receive notifications by regular mail. There is no evidence in the record that any of the notices that were sent by NYSOH to your mailing address were returned as undeliverable. Therefore, the notices are deemed sent and received.

You testified you may not have received the notices because "[REDACTED] was not added to the mailing address listed in your account. However, [REDACTED] was listed as your mailing address from November 11, 2013 through May 5, 2017, and was never changed.

Therefore, NYSOH properly notified you of an inconsistency in your account and that documentation was needed to confirm the income you listed in the account.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation. In your case, NYSOH could not confirm your household income and, therefore, your eligibility for financial assistance was terminated, as stated in the March 16, 2017 eligibility determination notice.

Any changes in APTC are to be made effective the date following the eligibility redetermination notice, which date was April 1, 2017.

Therefore, your financial assistance properly ended April 1, 2017, and the March 16, 2017 eligibility determination notice is AFFIRMED.

Your eligibility for financial assistance ended, effective April 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
