Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for December 1, 2016 through December 31, 2016?

Procedural History

On February 3, 2017, NYSOH received your paper application for financial assistance.

On February 24, 2017, NYSOH issued a notice advising you that more information, such as your date of birth, where you live, and how the people in your household are related to each other, as well as information regarding your child's coverage was needed in order to complete your application for financial assistance.

On April 13, 2017, NYSOH received another paper application for financial assistance.

On April 19, 2017, NYSOH issued a notice advising you that more information, such as your date of birth, where you live, and how the people in your household are related to each other, as well as information regarding your child's coverage was needed in order to complete your application for financial assistance.

On April 24, 2017, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for December 2016, January 2017, February 2017, and March 2017.

On April 25, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid. This eligibility was effective as of April 1, 2017.

On April 25, 2017 NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid for January 1, 2017 through March 31, 2017.

On May 6, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not found eligible for retroactive Medicaid for the month of December 2016.

On August 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing left open for fourteen days to allow you to submit supporting documents.

On April 14, 2017, NYSOH receive via fax a copy of your Social Security Disability award letter, your child's Social Security award letter, a print-out regarding an application you submitted to your local department of social services, and a copy of a paper application for financial assistance with health insurance dated January 3, 2017. These documents were collectively marked as Appellant's Exhibit #1 and incorporated into the record. The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from December 1, 2016 to December 31, 2016.
- 2) You testified that you filed your 2016 tax return as head of household and expect to file your 2017 tax return as head of household. You claimed one dependent on your 2016 tax return, your child, and you expect to claim one dependent, your child, on your 2017 tax return.
- 3) Your paper application for financial assistance, signed January 3, 2017, was received by NYSOH on February 3, 2017.
- 4) You testified that in December 2016 your household's only source of income was your social security disability benefit and your child's social security benefit.

- 5) You submitted your social security disability award letter which indicates that as of November 2016 your benefit will be \$1,028.00 per month.
- 6) You submitted your child's social security award letter which indicates that as of November 2016 his benefit will be \$439.00 per month.
- 7) You testified that you have outstanding medical bills from December 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for December 1, 2016 through December 31, 2016.

You file your taxes with a tax filing status of head of household and claim one dependent on your tax return. Therefore, you are in a two-person household.

NYSOH received your initial paper application for financial assistance on February 3, 2017.

You were ultimately found eligible for Medicaid, effective April 1, 2017.

You requested help in paying for medical bills for December 1, 2016 to March 31, 2017.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid from December 1, 2016 to December 31, 2016.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in December, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,843.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during December 2016.

You testified that your only source of income in December 2016 was your social security disability benefit. You submitted a social security disability award letter stating that as of November 2016 your benefit rate would be \$1,028.00. Therefore, the record indicates that in the month of December 2016, you had a monthly household income of \$1,028.00

Since NYSOH received your paper application on February 3, 2017, you had the right to be evaluated for Medicaid for the three months before the month of this application.

Therefore, your case is RETURNED to NYSOH to consider your request for retroactive coverage for December 2016 based on a household size of two people and household income of \$1,028.00 for the month of December 2016.

Decision

Your case is RETURNED to NYSOH to consider your request for retroactive coverage for December 2016 based on a household size of two and household income of \$1,028.00 for the month of December 2016.

How this Decision Affects Your Eligibility

This is not a final determination of your eligibility. Your case is sent back to NYSOH to redetermine your eligibility based on the evidence you presented at the hearing.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
