Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$314.00 per month in advance payments of the premium tax credit (APTC), eligible to receive cost-sharing reductions and not eligible for the Essential Plan or Medicaid, effective June 1, 2017?

Procedural History

On April 27, 2017, you uploaded your 2016 tax return to your NYSOH account.

Also on April 27, 2017, NYSOH redetermined your eligibility and systematically submitted an application for you for financial assistance.

On April 28, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$314.00 in APTC and eligible to receive cost-sharing reductions, effective June 1, 2017. That notice also stated that you were not eligible for the Essential Plan or Medicaid because your income was over the allowable income limits for those programs.

On May 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the determination of your eligibility for APTC insofar as you are seeking to be redetermined eligible for the Essential Plan or Medicaid.

On August 23, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On April 27, 2017, NYSOH redetermined your eligibility and systematically submitted an application on your behalf for financial assistance.
- 2) Also, on April 27, 2017, you uploaded your 2016 tax return to your NYSOH account.
- 3) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 4) You are seeking insurance for yourself.
- 5) The application that was submitted on April 27, 2017 listed annual household income of \$25,031.00 consisting of \$19,128.00 in IRA distributions, \$2,400.00 in dividends, and \$3,503.00 in capital gains.
- 6) You testified that the income utilized for the April 27, 2017 application was not correct and was from a prior application. You testified that after the April 27, 2017 eligibility determination, you uploaded your 2016 tax return to NYSOH.
- 7) You testified that based on your 2016 tax return you expect your 2017 annual household income to be \$24,941.00 consisting of \$18,335.00 in IRA distributions, \$3,103.00 in dividends and \$3,503.00 in capital gains.
- 8) Your application states that you will not be taking any deductions on your 2017 tax return.
- 9) Your application states that you live in [REDACTED].
- 10) You testified that you are seeking to be redetermined eligible for the Essential Plan or Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$ for a one-person household (81 Fed. Reg. 4036).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Legal Analysis

The issue is whether NYSOH properly determined that you were eligible to receive up to \$314.00 per month in APTC, eligible to receive cost-sharing reductions, and not eligible for the Essential Plan or Medicaid, all effective June 1, 2017.

The application that was submitted on April 27, 2017 listed annual household income of \$25,031.00 consisting of \$19,128.00 in IRA distributions, \$2,400.00 in dividends, and \$3,503.00 in capital gains.

You testified that the income information utilized for the April 27, 2017 application was not correct and was partly from a prior application you submitted to NYSOH. You testified that after the April 27, 2017 eligibility determination was issued, you uploaded your 2016 tax return to NYSOH.

You testified that you expect your 2017 annual household income to be \$24,941.00 consisting of \$18,335.00 in IRA distributions, \$3,103.00 in dividends and \$3,503.00 in capital gains.

Therefore, the April 28, 2017 eligibility determination was based on incorrect information, and is RESCINDED. Your case is being RETURNED to NYSOH to redetermine your eligibility for financial assistance based on a one-person household, an annual household income of \$24,941.00 and residing in [REDACTED].

Decision

The April 28, 2017 eligibility determination notice is RESCINDED.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
