## NOTICE OF DISMISSAL

On May 9, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that your child was enrolled in her Medicaid Managed Care plan, effective June 1, 2017. You appealed this determination.

On July 17, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 18, 2017, at 3:00 pm.

On August 18, 2017, a Hearing Officer called you at the telephone number you provided to NYSOH at 3:00 pm and 3:15 pm. On the second call, an individual answered, advised that you were not home, and provided an alternate number where you could be reached. At 3:17 pm and 3:30 pm the Hearing Officer called you at this alternate number. Although you answered the call at 3:30 pm, you stated that this was not a good time and terminated the phone call. The Hearing Officer placed one final call to you at 3:32 pm, but you did not answer.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
